(2) There shall be paid by every Irrigation Division such audit fee as the Commissioner may from time to time direct."

5. Section 39 of the Principal Law is hereby repealed Repeal of and the following section substituted therefor :--

Repeal of section 39 of Law 1 of 1931 and substitution of new section.

"Offences and penalties. 39.—(1) Any person who—

- (a) wilfully interferes with the flow or of new distribution of water connected with any irrigation works; or
- (b) wrongfully abstracts or diverts to his own use or to the use of any other person any water, whether running or not, connected with any Irrigation Division,

shall be guilty of an offence and shall be liable to imprisonment not exceeding one year or to a fine not exceeding ten pounds or to both.

- (2) Any person who—
 - (a) wilfully obstructs the Commissioner or any person deputed by him or his agents or contractors or any person appointed to carry out any work under this Law; or

(b) acts in contravention of or fails to comply

with any Rules made under this Law, shall be guilty of an offence and shall be liable to a fine not exceeding ten pounds.

6.—(1) Paragraph (f) of sub-section (2) of section 16 Repeal. is hereby repealed, the subsequent paragraph therein being re-numbered accordingly.

(2) Any Rule providing for a penalty for the infringement of any Rules made under the provisions of the Principal Law is hereby repealed.
