A.D. 1934. A LAW TO PROVIDE FOR THE EXEMPTION FROM PAYMENT  
32 of 1934. OF DUTIES OF CUSTOMS BY THE CYPRUS MINES  
CORPORATION UPON CERTAIN GOODS  
AND MATERIALS.

BE it enacted :—

Short title.

1. This Law may be cited as the Cyprus Mines Corporation (Exemption from Duties of Customs) Law, 1934.

Interpreta-  
tion.

2. In this Law—

“the Colony” means the Colony of Cyprus;

“the Corporation” means the Cyprus Mines Corporation and includes their successors and permitted assigns.

Exemption  
from duties.

3. Notwithstanding anything in the Customs, Excise and Revenue Law, 1899, or any enactment amending the same, duties of Customs shall not be charged—

(a) on any goods or materials of British Empire origin enumerated in the First Schedule to this Law and imported by the Corporation into the Colony between the 10th day of September, 1933, and the 31st day of December, 1934, both days inclusive;

(b) on any goods or materials enumerated in the Second Schedule to this Law and imported by the Corporation into the Colony between the 1st day of January, 1934, and the 31st day of December, 1943, both days inclusive; or

(c) on any goods or materials of British Empire origin enumerated in the Third Schedule to this Law and imported by the Corporation into the Colony between the 1st day of January, 1934, and the 31st day of December, 1943, both days inclusive:

Provided that such goods or materials are certified to be solely required for use by the Corporation for its mining or ore treating operations or in connection with the mill and power plant buildings, shops, warehouses, tanks and engineering structures belonging to the Corporation.

4. Notwithstanding anything in the Customs, Excise and Revenue Law, 1899, or any enactment amending the same, any goods or materials of non-British Empire origin enumerated in the Third Schedule to this Law and imported by the Corporation into the Colony between the 1st day of January, 1934, and the 31st day of December, 1943, both days inclusive, shall pay duties of Customs at the rate of one-sixth of the full rate of the duties of Customs in force at the time of the importation of such goods or materials.

Rate of duty on goods in Third Schedule of non-British Empire origin.

5. Nothing in this Law contained shall be construed to affect the rights of His Majesty, His heirs and successors, or of any body politic or corporate or of any other person or persons except such as are mentioned in this Law, and those claiming by, from or under them.

### FIRST SCHEDULE.

#### (SECTION 3 (a).)

1. Fabricated structural steel with bolts, nuts and rivets ready for erection.
2. Corrugated iron sheets, galvanized or ungalvanized, and fittings for attachment.
3. Steel sash and steel doors.
4. Reinforcing steel bars.
5. Punched steel plates ready for assembling into tanks.
6. Corrugated asbestos or composition sheets and fittings for attachment.

### SECOND SCHEDULE.

#### (SECTION 3 (b).)

1. Flotation reagents comprising chemicals, oils, and other substances for use in the flotation process of ore concentration.
2. Iron or steel or alloy balls, wearing plates, mantles, liners in all shapes, roll shells and discs, for use in ore crushing machinery or ore grinding mills.
3. Scrap iron and steel, loose, baled or compressed, and pig iron, for use in the precipitation of copper from solutions.
4. Crude petroleum, fuel or furnace oil, gas oil or Diesel oil.

### THIRD SCHEDULE.

#### (SECTIONS 3 (c) AND 4.)

1. Lubricating oils imported in bulk and not intended for distribution or resale.
2. Asbestos or composition sheeting in rolls to be used for flooring under mineral heaps.
3. Expanded metal and steel to be used in stopping operations.
