A LAW TO AMEND THE TREE PLANTING VILLAGE AREAS A.D. 1935. LAW, 1930. 22 of 1935.

BE it enacted :--

1. This Law may be cited as the Tree Planting Village Short title. Areas (Amendment) Law, 1935, and shall be read as one with the Tree Planting Village Areas Law, 1930, (herein- 28 of 1930. after called "the Principal Law"), and the Principal Law and this Law may together be cited as the Tree Planting Village Areas Laws, 1930 and 1935.

2. The definition "Owner in the village" in section 2 Amendment of the Principal Law is hereby amended by the insertion of section 2 of Law 28 of immediately after the word "possessor" (line 4) of the 1930. words "of not less than ten donums".

3. Sub-section (4) of section 10 of the Principal Law Repeal of is hereby repealed and the following section substituted of Law 28 therefor :---

"(4) Every such meeting shall determine whether an ^{substitution} of new subarea or areas shall be reserved as the Tree Planting section. Area of the village and shall fix and describe with boundaries and particulars the area or areas so reserved:

Provided that such area or areas shall not comprise in the aggregate more than one-quarter of the total extent of the Arazi Mirié lands situated within the limits of the village."

4. Section 18 of the Principal Law is hereby amended as Amendment follows :--

(a) By the deletion of sub-section (1) and by the of 1930. substitution therefor of the following sub-section :-

"(1) If, after the commencement of any plantation on any land in any Tree Planting Area, any animal is grazed, driven, led or taken or allowed or suffered to be grazed, driven, led or taken, whether by the owner or any other person in, upon, through or along any such area the owner of such animal and the person in whose charge it was at the time of such grazing, driving, leading or taking ; or "

(b) By the addition at the end thereof of the following proviso :-

"Provided that in the case of an offence under sub-section (1) of this section the offender shall,

in addition, be adjudged to pay the sum of one shilling for every animal in respect of which the offence has been committed."

5. Section 19 of the Principal Law is hereby repealed and the following section substituted therefor :-section 19 of

> " Power to Governor to make regulations.

19. The Governor may make regulations to be published in the Cyprus Gazette-

- (a) prescribing the forms to be used in connection with any act to be done under this Law:
 - (b) generally for the better carrying into effect of the purposes of this Law.'

6. The Principal Law is hereby amended by the insertion immediately after section 19 of the following section :---

" Establish-19A. The Commissioner may by notification under his hand-

- (a) establish for any village a Fund into which all fines recovered under this Law for offences committed in the Tree Planting Area of such village shall be paid;
- (b) prescribe the object for which and the mode in which any fines recovered under this Law shall be utilized or expended."

This Law came into operation on 23rd August, 1935.
