BE it enacted:-

Short title.

8 of 1914.

1. This Law may be cited as the Carob Weighing and Shipping Place Improvement (Amendment) Law, 1935, and shall be read as one with the Carob Weighing and Shipping Place Improvement Law, 1914, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Carob Weighing and Shipping Place Improvement Laws, 1914 and 1935.

2. Section 4 of the Principal Law is hereby repealed and the following substituted therefor:—

"Weighing of carobs transported from a carob shipping place.

4.—(1) All carobs transported from a carob shipping place whether by land or sea shall be weighed by an authorized weigher.

(2) A fee at a rate not exceeding two piastres shall be levied and paid for each Aleppo cantar of carobs weighed under the provisions of sub-section (1) of this section.

(3) The fee prescribed by sub-section (2) of this section shall be payable to the authorized weigher.

(4) Where any carobs weighed under the provisions of this section are again weighed for revenue purposes no fee shall be levied under this Law for such further weighing."

Amendment of section 5 (4) of Law 8 of 1914. **3.** Sub-section (4) of section 5 of the Principal Law is hereby amended by the deletion of the word "exportation" and the substitution therefor of the word "transport".

Repeal of section 6 (1) of Law 8 of 1914 and substitution of new sub-section.

- 4. Sub-section (1) of section 6 of the Principal Law is hereby repealed and the following substituted therefor:—
  - "(1) The weighing fees when collected shall be paid to the Commissioner who shall place them to the credit of a fund to be called 'The Improvement Fund for..... (insert the name of the carob shipping place)'."

5. Section 12 of the Principal Law is hereby repealed and Repeal of the following substituted therefor:-

" Notice to authorized weigher or officer of Customs.

12.—(1) Any person intending to transport substitution carobs from a carob shipping place shall-

- (a) in the case of carobs intended for transport by land, inform an authorized weigher or in his absence the Commissioner;
- (b) in the case of carobs intended for transport by sea, inform the officer of the Customs in charge of the carob shipping place,

and such person shall afford the weigher every reasonable facility for weighing the carobs.

- (2) Any person who—
- (a) removes from any carob shipping place any carobs before the same have been weighed by an authorized weigher; or
- (b) fails or neglects to afford to the authorized weigher every reasonable facility for weighing any carobs intended for transport from any carob shipping place,

shall be guilty of an offence and shall be liable to a fine not exceeding ten pounds and shall in addition be liable to pay the prescribed weighing fee."

6. Sub-section (2) of section 13 of the Principal Law Amendment is hereby amended by the deletion of the word "exporting" of section 13 (2) of and the substitution therefor of the word "transporting". Law 8 of
