BE it enacted :--

Amendment of section 7 of Law 14 of 1932. 1. This Law may be cited as the Midwifery (Amendment) Law, 1936, and shall be read as one with the Midwifery Law, 1932, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Midwifery Laws, 1932 and 1936.

2. Section 2 of the Principal Law is hereby amended by the deletion of the definition "Medical Assessors" and the substitution therefor of the following definition :—

"Medical Council" means the Medical Council constituted under the Medical Registration Law, 1936.

3. Section 7 of the Principal Law is hereby amended as follows:—

(i) By the addition immediately after paragraph (c) of the following paragraph :—

" (d) the cancellation by the Registrar under the provisions of section 12 of this Law of any

" Replacement in register or list of name of midwife.

12A. Any person registered as a midwife or practising midwifery by special licence under the provisions of this Law whose name has been removed from the register or from the list kept under the provisions of section 6 of this Law, on the ground that she was unfit to perform the functions of a midwife by reason of physical disability or infirmity, may apply to the Registrar for the replacement of her name in the register or such list and the Registrar, if satisfied that the applicant has fully recovered from the physical disability or infirmity in respect of which her name was removed. from the register or such list and that she does not suffer from any other physical disability or infirmity which would render her unfit to perform the functions of a midwife, may replace her name in the register or the list kept under the provisions of section 6 of this Law."
