A LAW FURTHER TO AMEND THE LAW RELATING TO THE
ACQUISITION OF LAND AND OTHER IMMOVABLE
PROPERTY FOR PUBLIC PURPOSES.

BE it enacted :—

1. This Law may be cited as the Land Acquisition (Amendment) Law, 1936, and shall be read as one with the Land Acquisition Laws, 1899 and 1928, (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Land Acquisition Laws, 1899 to 1936.

2. Section 2 of the Principal Law is hereby amended as follows :—

(a) The following definition shall be substituted for the definition of "Land" :—

" 'land' includes—

- (a) land with the grazing rights on or over such land;
- (b) land with all water and water rights on, over or under such land;
- (c) buildings and other erections;
- (d) trees, vines and standing crops;

- (e) easements, privileges and liberties appertaining or reputed to appertain to land ;
- (f) water and water rights, held independently of land, where the acquisition thereof—
 - (i) is required for the construction or service of any railway or harbour, provided that there shall not be any other reasonably accessible means of obtaining such water as is necessary for the purposes of such railway or harbour, or
 - (ii) is required for the purposes of any land already acquired or which is being acquired under the provisions of this Law.”

(b) The words “or by a public body recognized as such for the purposes of this Law by an instrument under the hand of the Governor” shall be inserted at the end of the definition of “Undertaking of public utility”.

Amendment of section 7 of Law 6 of 1899 as amended by section 3 of Law 2 of 1928.

3. Section 7 of the Principal Law is hereby amended by the insertion of the words “or in the public body concerned” after the words “Air Force Authorities”.

Amendment of section 11 of Law 6 of 1899 as amended by section 4 of Law 2 of 1928.

4. Section 11 of the Principal Law is hereby amended by the insertion of the words “or by the public body concerned” after the words “Air Force Authorities”.

Amendment of section 12 of Law 6 of 1899 as amended by section 5 of Law 2 of 1928.

5. Section 12 of the Principal Law is hereby amended by the insertion of the words “or by the public body concerned” after the words “Air Force Authorities”.

Amendment of section 13 of Law 6 of 1899 as amended by section 6 of Law 2 of 1928.

6. Section 13 of the Principal Law is hereby amended by the insertion of the words “or the public body concerned” after the words “Air Force Authorities” wherever those words occur therein.

This Law came into operation on 4th September, 1936.
