BE it enacted :-

1. This Law may be cited as the Co-operative Credit short title. Societies (Amendment) Law, 1937, and shall be read as one with the Co-operative Credit Societies Laws, 1914 to 1936, 13 of 1914 (hereinafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Co-operative 10 of 1928 Credit Societies Laws, 1914 to 1937.

2. Section 33 of the Principal Law is hereby repealed and Repeal of the following section substituted therefor:-

"Deposit and investment of society's funds.

33. A society may with the approval of the Principal Law and Registrar first obtained deposit or invest its substitution funds or any part thereof in any bank or in any society registered under the Co-operative Societies Law, 1923."

BE it enacted :-

1. This Law may be cited as the Co-operative Societies Short title. (Amendment) Law, 1937, and shall be read as one with the Co-operative Societies Law, 1923, (hereinafter called "the 10 of 1923. Principal Law "), and the Principal Law and this Law may together be cited as the Co-operative Societies Laws, 1923 and 1937.

Amendment of section 3 of the Principal Law.

- 2. Section 3 of the Principal Law is hereby amended by the insertion immediately after paragraph (b) of the following paragraph (c), the subsequent paragraphs being re-lettered accordingly:-
 - (c) Co-operative Credit Society means a Co-operative Society registered under the provisions of the Co-operative Credit Societies Laws, 1914 to 1937."

Repeal of section 6 of the Principal Law and substitution of new section.

3. Section 6 of the Principal Law is hereby repealed and the following section substituted therefor:

"Registration of societies the members of which consist of other societies.

6. Notwithstanding anything in this or in any other Law contained a society the members of which consist of societies or Co-operative Credit Societies or of both societies and Co-operative Credit Societies may be registered under this Law with limited liability."

Repeal of section 7 of the Principal Law and substitution of new section.

4. Section 7 of the Principal Law is hereby repealed and the following section substituted therefor:

"Conditions of registra-

tion.

7. No society, other than a society of which a member is a society or a Co-operative Credit Society, shall be registered under this Law which does not consist of at least ten persons each of whom is above the age of eighteen years."

Repeal of section 10 of the Principal Law and substitution of new section.

5. Section 10 of the Principal Law is hereby repealed and the following section substituted therefor:

"Application for registration.

10.—(1) For the purposes of registration an application shall be made to the Registrar.

(2) The application shall be signed—

(a) in the case of a society of which no member is a society or a Co-operative Credit Society by at least ten persons qualified accordance with the requirements of section 7, and

(b) in the case of a society of which a member is a society or a Co-operative Credit Society by a duly authorized person on behalf of every such society or Co-operative Credit

Society.

(3) The application shall be accompanied by two copies of the proposed bye-laws of the society."
