(3) If any person who is subject to any of the disqualifications hereinbefore mentioned shall be appointed as a member of any Board of Education or Town Committee or Committee of Management, such appointment shall be void as regards such person.

(4) Every person who whilst subject to any of the disqualifications hereinbefore mentioned shall sit or vote in a Board of Education or Town Committee or Committee of Management, shall, for every day on which he sits or votes, forfeit the sum of ten pounds, to be recovered by action in the District Court by any person who shall sue for the same.

(5) Nothing in sub-section (2) (c) contained shall apply to any public officer in the service of the Colony other than Orthodox-Christian."

A LAW TO PROVIDE FOR THE APPOINTMENT OF BRITISH SUBJECTS TO PUBLIC BODIES AND TO PUBLIC OFFICES.

BE it enacted :-

1. This Law may be cited as the Public Bodies and Public Offices (Appointments) Law, 1937.

2. In this Law-

"public body" means any Board, Commission, Committee or Council-

(a) established by or under any Law, or

(b) which has power to act under and for the purposes of any Law;

"public office" means any office-

- (a) the power of appointing or nominating a person to which, or
- (b) the power of approving the appointment or nomination of a person to which,

is vested in the Governor or in any public officer or in any public body.

3. Where by or under any Law, public instrument or Appointother lawful authority-

(a) the Governor or any public authority is empowered to public

to appoint or nominate persons to serve as officers or members on any public body; or

- (b) the Governor or any public officer or any public to persons body is empowered-
 - (i) to appoint or nominate a person to any public subjects. office, or
 - (ii) to approve the appointment or nomination of a person to any public office,

such power of appointment, nomination or approval as aforesaid shall be exercisable by the Governor, public authority, public officer or public body, as the case may be, only in respect of persons who are British subjects.

A LAW TO AMEND THE PUBLIC HEALTH (VILLAGES) LAW, 1936.

BE it enacted :-

1. This Law may be cited as the Public Health short title. (Villages) Amendment Law, 1937, and shall be read as one with the Public Health (Villages) Law, 1936, (here- 19 of 1936. inafter called "the Principal Law"), and the Principal Law and this Law may together be cited as the Public Health (Villages) Laws, 1936 and 1937.

2. Section 4 of the Principal Law is hereby repealed and Repeal of the following section substituted therefor :-

" Constitution of Village Health Commission in villages where there is more than one Village Commission.

4.--(1) Where in any village there is more than one Village Commission, the Village Health of new Commission shall consist of the Mukhtar and one Aza to be appointed by the Commissioner from each such Village Commission.

(2) The Commissioner shall appoint from among such Mukhtars a chairman and a vice-chairman of the Village Health Commission."
