A LAW TO AMEND THE LAW RELATING TO CUSTOMS.

Governor.

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows:-

1. This Law may be cited as the Customs (Amendment short title. No. 2) Law, 1941, and shall be read as one with the Customs Laws, 1936 to 1941, (hereinafter referred to as "the principal Law"), and the principal Law and this Law may together be cited as the Customs Laws, 1936 to (No. 2) 1941.

Amendment of the First Schedule to the principal Law.

- 2. The First Schedule to the principal Law is hereby amended as follows:—
 - (a) by the deletion of items 2, 4, 13, 33, 34, 48, 50, 55, 62, 63, 72, 78, 83, 88, 94, 96, 97, 98, 106 and 120 and the substitution therefor of the items bearing the same numbers in the Schedule to this Law.
 - (b) by the addition of the following new item:—
