THE STATUTE LAWS OF CYPRUS

No. 24 of 1947.

A Law to amend the Immigration Laws, 1936 to 1939.

Officer Administering the Government.

B^E it enacted by His Excellency the Officer Administering the Government and Commander-in-Chief of the Colony of Cyprus as follows:—

1. This Law may be cited as the Immigration (Amend-short title. ment) Law, 1947, and shall be read as one with the Immigration Laws, 1936 to 1939, (hereinafter referred to 16 of 1936 as "the principal Law"), and the principal Law and this \$\frac{8}{31}\$ of \$\frac{1937}{1938}\$ Law may together be cited as the Immigration Laws, 1936 14 of 1939 to 1947.

Amendment of section 2 of the principal Law.

2. Section 2 of the principal Law is hereby amended by the deletion therefrom of the definition "native of the Colony" (as set out in section 2 of Law 14 of 1939) and the substitution therefor of the following definition:—

"'native of the Colony' means any person who, not being recognized by any foreign State as having acquired its nationality on or since the 5th November, 1914—

(a) was born in the Colony or whose father was

born in the Colony; or

No. 2A: 5.10.1943 (b) obtained the status of a British subject by virtue of the Cyprus (Annexation) Orders in Council, 1914 to 1943, or by reason of the grant by the Governor of a certificate of naturalization under the British Nationality and Status of Aliens Acts, 1914 to 1943; or

(c) is the wife of a person to whom any of the foregoing paragraphs applies not living apart from such person under a decree of a competent Court or under a deed of

separation; or

(d) is a child, step-child or adopted child having been adopted in a manner recognized by law, under the age of eighteen years, of a person to whom any of the foregoing paragraphs applies."

Amendment of section 13 (1) of the principal Law.

3. Sub-section (1) of section 13 of the principal Law is hereby amended by the insertion therein immediately after the word "entry" (line 2) of the words "and any person so doing shall be deemed to be a prohibited immigrant".

Amendment of section 19 of the principal Law. 4. Section 19 of the principal Law is hereby amended by the insertion therein immediately after sub-section (3) of the following sub-section:—

"(4) Notwithstanding anything in this Law contained, the Principal Immigration Officer may, in his discretion, order a prohibited immigrant who has arrived by sea to leave the Colony in the ship in which he arrived without specifying the place to which he is deported."
