**THE STATUTE LAWS OF CYPRUS**

**No. 8 OF 1948.**

A LAW TO AMEND THE SHIPPING DUES LAWS, 1917 TO 1944.

**BE** it enacted by His Excellency the Governor and  
Commander-in-Chief of the Colony of Cyprus as  
follows:—

1. This Law may be cited as the Shipping Dues (Amendment) Law, 1948, and shall be read as one with the Shipping Dues Laws, 1917 to 1944, (hereinafter referred to as "the principal Law"), and the principal Law and this Law may together be cited as the Shipping Dues Laws, 1917 to 1948.

2. Section 3 of the principal Law is hereby amended as follows :—

- (a) by the deletion therefrom of the figure “2cp.” (line 4) and the substitution therefor of the figure “4p.”;
- (b) by the deletion therefrom of the figure “1cp.” (line 5) and the substitution therefor of the figure “2p.”;
- (c) by the deletion therefrom of the words “twelve pounds” (line 7) and the substitution therefor of the words “thirty-six pounds”.

3. Section 4 of the principal Law is hereby amended by the deletion therefrom of the words “six pounds” (line 6) and the substitution therefor of the words “eighteen pounds”.

Amendment

Law.

4. Section 7 of the principal Law is hereby amended as follows :—

- (a) by the deletion from sub-section (1) thereof of the figure “1cp.” (line 9) and the substitution therefor of the figure “2p.”;
- (b) by the deletion from sub-section (2) thereof of the words “six pounds” (line 3) and the substitution therefor of the words “eighteen pounds”.

5. Sub-section (1) of section 9 of the principal Law is hereby amended by the deletion therefrom of the words “one shilling” (line 3) and the substitution therefor of the words “two shillings”.

Amendment  
of section 12

6. Sub-section (3) of section 12 of the principal Law is hereby amended as follows :—

- (a) by the deletion therefrom of the words “one shilling” (line 7) and the substitution therefor of the words “two shillings”;
- (b) by the deletion therefrom of the words “five shillings” (line 8) and the substitution therefor of the words “fifteen shillings”.
