THE STATUTE LAWS OF CYPRUS

No. 5 of 1950.

A Law to amend the Secondary Education Laws, 1935 and 1936.

[28th March, 1950.

A. B. WRIGHT,] Governor.

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :---

1. This Law may be cited as the Secondary Education short title. (Amendment) Law, 1950, and shall be read as one with the Secondary Education Laws, 1935 and 1936 (hereinafter 25 of 1935 referred to as "the principal Law"), and the principal 2 of 1936 Law and this Law may together be cited as the Secondary Education Laws, 1935 to 1950. Repeal of section 24 of the principal Law and substitution of new section.

and the "Governing body for Moslem Secondary Schools.

2. Section 24 of the principal Law is hereby repealed and the following section substituted therefor :—

> 24.—(1) There shall be one governing body for all Moslem Secondary Schools registered under the provisions of this Law and it shall be composed of twelve members of the Moslem community having a knowledge of, and interest in, Moslem Secondary Education, appointed by the Governor:

> Provided that, of the twelve members, there shall be appointed not less than one member from each District.

> (2) The Governor shall appoint a Chairman and a Vice-Chairman from among the members of the governing body and, if the Chairman or Vice-Chairman are not present at any meeting, the members present shall choose one of their number to be Chairman for that meeting.

> (3) Every member of the governing body appointed as in sub-section (1) hereof, shall hold office for a period of two years from the date of his appointment:

> Provided that the Governor may, if he deems it expedient, terminate at any time the appointment of any such member."

Repeal of section 28 (1) of section 28 of the principal Law is hereby repealed and the following sub-section substituted therefor :—

"(1) All property vested in any secondary school to which section 23 or 24 applies and any property which may hereafter be acquired by or on behalf of any such school shall if movable vest, and if immovable vest and be registered—

- (a) in the case of a Greek-Christian secondary school, in the Chairman of the Town Committee as constituting the governing body for such school under section 23;
- (b) in the case of Moslem secondary schools, in the Chairman of the governing body constituted under section 24,

to be held in trust for the school or schools concerned."

4. This Law shall come into operation on the first day of July, 1950.
