BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :---

1. This Law may be cited as the Press (Amendment) Law, 1951, and shall be read as one with the Press Law, 1947 (hereinafter referred to as "the principal Law"), 28 of 1947 and the principal Law and this Law may together be cited as the Press Laws, 1947 and 1951.

2. Section 2 of the principal Law is hereby amended \sim by the deletion therefrom of the definition of "company" and the substitution therefor of the following definition :—

"'company' means a company formed and registered under the Companies (Limited Liability) Laws, 1922 to 1944, or under the Companies (Limited by Guarantee) Law, 1949, or any Law amending or substituted for the same;"

3. Section 4 of the principal Law is hereby repealed and the following section substituted therefor :—

4.—(1) Subject to the provisions of subsection (2) hereof, upon receiving a declaration and a bond, as in section 3 of this Law provided, the Colonial Secretary shall file or cause the same to be filed in his office and shall, thereupon, give or cause to be given to the proprietor of the newspaper, in respect of which the declaration and bond were furnished, a receipt bearing the date on which such declaration and bond were furnished, and such receipt shall be admissible in all proceedings as evidence of all that is stated therein relating to such declaration and bond.

(2) The Colonial Secretary may refuse to accept the filing of a declaration and a bond and refuse the issue of a receipt as in subsection (1) hereof provided, if, in his opinion, the newspaper in respect of which the declaration and bond are furnished is substantially under the same management, control or direction as a newspaper suspended under section 11 of this Law and the Colonial Secretary is of opinion that it is intended to replace any newspaper so suspended :

Provided that any person aggrieved by any such refusal of the Colonial Secretary may, within seven days from the date of the communication to him of such refusal, appeal to the Governor in Council whose decision thereon shall be final and conclusive.

4. The principal Law is hereby amended by the insertion therein, immediately after section 6, of the following section :—

"Withdrawal of bond and security by proprietor.

 d_{d}^{d} 6A.—(1) A proprietor may, at any time, after the expiration of two years from the date of the last publication of his newspaper,

apply to the Colonial Secretary for the cancellation of the bond and the withdrawal of any security deposited or given by the proprietor himself in connection therewith and. thereupon, the Colonial Secretary shall cancel such bond and shall return it to the proprietor together with any security which the proprietor has deposited or given in pursuance of the provisions of section 3 of this Law.

(2) Nothing in this section shall affect the provisions of section 5 of this Law with regard to the withdrawal of a surety as in that section provided."

5. The principal Law is hereby amended by the insertion Insertion of therein, immediately after section 11, of the following new section 11, in the section :-

principal Law.

" Power to Governor in Council to prohibit importation, etc., of newspapers.

11A.-(1) The Governor in Council may, by order published in the Gazette, prohibit the importation, introduction or circulation in the Colony of any newspaper published outside the Colony which appears to the Governor in Council to be contrary to religion or morality or prejudicial to peace, public order or good government in the Colony.

(2) Any person who, without lawful authority or excuse, the proof of which lies upon him. has in his possession or who sells or distributes any such prohibited newspaper or reproduces or publishes any of the contents of any such newspaper shall be guilty of an offence and shall be liable to imprisonment not exceeding six months or to a fine not exceeding twenty-five pounds or to both such imprisonment and fine and every copy of such newspaper shall be forfeited."
