No. 14 of 1954.

A Law to provide for the preparation and publication of a Collected and Revised Edition of the Subsidiary Legislation of Cyprus.

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows:—

1. This Law may be cited as the Revised Edition (Sub- short title, sidiary Legislation) Law, 1954.

Interpretation.

2. In this Law—

"the revised edition" means the new and revised edition of the subsidiary legislation of the Colony prepared under the authority of this Law;

"Rules of Court" means such public instruments, affecting the administration of justice, as, in the opinion of the Chief Justice, should be included in the part of the revised edition to be prepared under his supervision;

"subsidiary legislation" means any Order in Council, order, proclamation, regulations, rules, Rules of Court, bye-laws or notice made or issued under the authority of any Law.

Preparation of revised edition of subsidiary legislation. 3. The Governor may authorize the preparation of a revised edition (in one or more volumes) of any subsidiary legislation (other than the Rules of Court) in force in the Colony on the 30th day of June, 1953, and of any Rules of Court in force in the Colony on the 31st December, 1953:

Provided that any subsidiary legislation which has no legislative effect, or which is not of a permanent nature, or which, in the case of Rules of Court, in the opinion of the Chief Justice, and in the case of other subsidiary legislation, in the opinion of the Attorney-General, should not be included in the revised edition, may be omitted from the revised edition.

Manner of preparation.

4. In the preparation of the revised edition there shall be the like powers to do all things in respect of the subsidiary legislation to be included in the revised edition as are conferred on the Commissioner under section 4 of the Cyprus Laws (New Edition) Law, 1950, in respect of Laws.

- Bringing revised edition into force and validity and operation of revised edition.
- 5. The Governor may, by proclamation, approve the revised edition and order that it shall come into force from such date as he shall in such proclamation specify, and, as from such date, the revised edition shall be deemed to be and shall be without any question whatsoever in all courts and for all purposes whatsoever the sole authentic edition of the subsidiary legislation therein contained.

Construction of references to repealed or amended subsidiary legislation. 6. Wherever in any enactment, subsidiary legislation, or in any document of whatever kind, reference is made to any subsidiary legislation repealed or otherwise affected by the operation of this Law, the reference shall, where necessary and practicable, be deemed to extend and apply to the corresponding subsidiary legislation contained in the revised edition.

7. A LAW TO AMEND THE SALE OF INTOXICATING LIQUORS LAW. CAP. 152

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :-
