Amendment of section 18 of the principal Law. 2. Section 18 of the principal Law is hereby amended by the addition thereto, immediately after paragraph (e), of the following paragraph (the full stop at the end of the said paragraph (e) being substituted by a semicolon):—

"(f) prevent any person from grazing on his own lands within any Tree Planting Area, any camel, horse, mare, bull, cow, ass or mule or the young of such animals:

Provided that such animals and their young are at all times tethered in such manner as to prevent damage to any tree:

Provided further that the Village Commission of the village concerned may at any time, having regard to the age of the trees, the area of the lands aforesaid, the conduct of any such person, and having regard to all material considerations, prohibit, limit or control such grazing in such manner as the Village Commission may deem fit."

CAP. 98 A LAW TO AMEND THE GAME AND WILD BIRDS PROTECTION 23 of 1950 3 of 1953

BE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows :--

Short title.

Cap. 98 23 of 1950 3 of 1953. **1.** This Law may be cited as the Game and Wild Birds Protection (Amendment) Law, 1955, and shall be read as one with the Game and Wild Birds Protection Law (hereinafter referred to as "the principal Law").

2. Paragraph (b) of sub-section (1) of section 5 of the Amendment principal Law (as set out in section 2 of Law 3 of 1953) is of section 5 hereby amended as follows :----

(a) by the deletion therefrom of the words "crows or Law.

- magpies" in line 5 thereof and the substitution therefor of the following words "crows, magpies, ravens or foxes (hereinafter referred to as 'vermin')";
- (b) by the deletion therefrom of the words "crow or magpie" in lines 7 and 8 thereof and the substitution therefor of the word "vermin"
  - (c) by the deletion therefrom of the words " crows and magpies" in line 8 of sub-paragraph (i) of the proviso thereto and the substitution therefor of the word "vermin".

3. Section 14 of the principal Law is hereby repealed and Repeal of the following section substituted therefor :--

"14. No person shall shoot, kill, take or pursue any game principal Law and or wild bird-

- (a) between sunset and sunrise;
- (b) by making use of a decoy or shelter;
- (c) by making use of any motor vehicle whatsoever for the purpose of shooting therefrom ;
- (d) by employing or causing to be employed the method, or engage or take part in the practice commonly known as 'pantima' or any other method or practice having effect similar to that of 'pantima';

and any person who acts in contravention of this section shall be guilty of an offence :

Provided that the Governor may, subject to such conditions as he may therein see fit to impose, and by order to be published in the Gazette, suspend the operation of paragraph (a) or paragraph (b) hereof in respect of such wild birds and within such areas as may be specified therein.".
