A LAW TO AMEND THE SALE OF INTOXICATING LIQUORS LAW. CAP. 152

JOHN HARDING, Governor.

[6th February, 1957.

RE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as follows:-

1. This Law may be cited as the Sale of Intoxicating Short title. Liquors (Amendment) Law, 1957, and shall be read as one Cap. 152 with the Sale of Intoxicating Liquors Law (hereinafter 15 of 1954. referred to as "the principal Law").

Amendment of the principal Law by the insertion of new section 9A. 2. The principal Law is hereby amended by the insertion therein, immediately after section 9, of the following new section:—

"Police messes, etc.

- 9A.—(1) Notwithstanding the provisions of section 4 of this Law, the Licensing Authority may issue a retailer's licence in respect of any canteen, mess or institution which is operated, maintained or carried on, with the consent or approval of the Governor, for the exclusive use of members of the Cyprus Police Force, without a certificate of the District Council being furnished to such Licensing Authority.
- (2) The provisions of section 8, paragraphs (d) and (e) of section 9 and section 15 of this Law shall not apply in respect of any retailer's licence issued under the provisions of this section or to the premises or place in respect of which such retailer's licence has been issued or to the holder of such retailer's licence."

Amendment of the Schedule to the principal Law.

3.—(1) The Schedule to the principal Law (as set out in section 5 of Law 15 of 1954) is hereby amended by the deletion of item 3 of Part A thereof and the substitution therefor of the following item:—

- "3. Club Retail Licence (section 6 (c)):
 In respect of any premises or place situated in—
 - (a) any of the towns of Nicosia, Limassol, Famagusta (including Varosha), Larnaca, Paphos (including Ktima) and Kyrenia

£6 per annum."

(2) This section shall come into force on the thirteenth day of March, 1957.
