## THE STATUTE LAWS OF CYPRUS

No. 28 of 1958.

A Law to amend the Pensions Law.

CAP. 288. 4 of 1952 1 of 1955 29 of 1956.

DE it enacted by His Excellency the Governor and Commander-in-Chief of the Colony of Cyprus as

1. This Law may be cited as the Pensions (Amendment) Short title. Law, 1958, and shall be read as one with the Pensions Law Cap. 288 4 of 1952 1 of 1955 (hereinafter referred to as "the principal Law").

Amendment of the principal Law by the substitution of "service under the Government of Cyprus" for "the service of Cyprus" and "service in Cyprus".

Amendment of section 2 of the principal Law. 29 of 1956.

2. The principal Law is hereby amended by the substitution for the words "the service of Cyprus" and "service in Cyprus", wherever they occur in the principal Law, of the words "service under the Government of Cyprus".

- 3.—(1) Paragraph (a) of the definition of "pensionable emoluments", contained in sub-section (1) of section 2 of the principal Law (as set out in section 2 of the Pensions (Amendment) Law, 1956), is hereby deleted and the following paragraph substituted therefor:—
  - "(a) in respect of service under the Government of Cyprus includes—
    - (i) salary,
    - (ii) overseas allowance,
    - (iii) personal allowance,
    - (iv) board allowance,
    - (v) board and lodging allowance,
    - (vii) good conduct pay, (vii) merit allowance,
    - (viii) the portion of the cost of living allowance amounting to twelve and a half per centum of the sum total of salary and overseas allowance,

but does not include duty allowance, entertainment allowance or any other emoluments whatever;".

(2) Sub-paragraphs (iv) and (v) of paragraph (a) of the definition of "pensionable emoluments", contained in sub-section (1) of section 2 of the principal Law and as set out in sub-section (1) of this section, shall be deemed to have come into force on the first day of July, 1955, and sub-paragraph (viii) of the said paragraph (a) of the said definition shall be deemed to have come into force on the first day of January, 1957.

Amendment of section 16 of the principal Law. 1 of 1955.

4. Sub-section (3) of section 16 of the principal Law (as set out in section 5 of the Pensions (Amendment) Law, 1955) is hereby amended by the substitution for the words "Colonial Superannuation Scheme" (line 5) of the words "Oversea Superannuation Scheme".
