- 5. Where any person who sells or exposes for sale or holds stocks of any wheat refuses, on demand being made to him by a prospective purchaser, to sell to him any such wheat and such refusal is in my opinion, or in the opinion of the Commissioner of the District, unreasonable, such person shall at my request, or at the request of the said Commissioner, deliver such wheat to me or to him to be sold at a price in accordance with the provisions of clause 2 of this Order or to be disposed of in such manner as I or the said Commissioner may in that behalf direct.
  - 6. Any person who—
    - (a) acts in contravention of the provisions of clause 2 or 4 or 5 of this Order, or
- (b) makes a false declaration under clause 4 of this Order, shall be liable to the penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939.

# THE EMERGENCY POWERS (CYPRUS DEFENCE) REGULATIONS, 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Regulation of Sale Prices) (Barley) Order, 1939, and shall come into operation on and from the date of its publication in the *Gazette*.

2. No person shall—

(a) sell or purchase, or

(b) offer for sale or attempt to sell or purchase, or

(c) either directly or indirectly make any arrangement for the sale or purchase of,

any barley in any of the towns or villages specified in the first column of the Schedule hereto at a price in excess of the price shown in the second column of the said Schedule opposite such town or village.

- 3. The Commissioner of each District, if so required by me, shall appoint Inspectors to enquire into the stocks of barley which are in the possession or control of any person or generally of all persons residing in any town or village within his District.
- 4. Any person when so required to do by an Inspector appointed under clause 3 of this Order shall make a declaration of the stock of barley in his possession or control and any such Inspector may enter upon any premises for the purpose of carrying out any inspection or search reasonably required in order to obtain the necessary information concerning the amount or condition of the stock of any such barley.
- 5. Where any person who sells or exposes for sale or holds stocks of any barley refuses, on demand being made to him by a prospective purchaser, to sell to him any such barley and such refusal is in my opinion, or in the opinion of the Commissioner of the District, unreasonable, such person shall at my request, or at the request of the said Commissioner, deliver such barley to me or to him to be sold at a price in accordance with the provisions of clause 2 of this Order or to be disposed of in such manner as I or the said Commissioner may in that behalf direct.
  - 6. Any person who-
