- 8. No person shall, in any of the towns specified in column (1) of the said Schedule, sell by retail to any purchaser of charcoal more than one week's supply during any one week.
 - 9. For the purposes of this Order, the term "by wholesale" means—

(a) any sale or purchase of, or

(b) any offer for sale of, or

(c) any attempt to sell or purchase, or

(d) any arrangement made, either directly or indirectly, for the sale or purchase of,

any charcoal in quantities in excess of 50 okes at any one time or at any single transaction.

10. Any person who—

(a) acts in contravention of the provisions of clause 2 or 3 or 5 or 6 or 7 or 8 of this Order, or

(b) makes a false declaration under clause 5 of this Order, shall be liable to the penalties prescribed in Regulation 63 (1) of the Emergency Powers (Cyprus Defence) Regulations, 1939.

THE EMERGENCY POWERS (CYPRUS DEFENCE) REGULATIONS, 1939.

Order made by the Competent Authority under Regulation 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Regulation of Sale Prices) (Imported Articles) Amendment Order, 1939, and shall be read as one Gazette: with the Defence (Regulation of Sale Prices) (Imported Articles) Order, Supplement 1939, (hereinafter called "the Principal Order"), and the Principal No. 3:

Order and this Order may together be cited as the Defence (Regulation 15.9.1939). Order and this Order may together be cited as the Defence (Regulation of Sale Prices) (Imported Articles) Orders, 1939.

- 2. The proviso to clause 2 (1) of the Principal Order is hereby amended by the deletion therefrom of the words "or prior to".
- 3. Clause 2 (2) (b) of the Principal Order is hereby amended by the deletion therefrom of the words "or prior to".
- 4. Clause 6 of the Principal Order is hereby amended by the deletion therefrom of the words "clause 3" and by the substitution therefor of the words "clause 5".
