THE EMERGENCY POWERS (CYPRUS DEFENCE)
REGULATIONS, 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 42.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 42 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Kerosene) Amendment Order, 1939, and shall be read as one with the Defence (Kerosene) Order, 1939, (hereinafter called "the Principal Order"), and the Principal Order and this Order may together be cited as the Defence (Kerosene) Orders, 1939.

3. Clause 14 of the Principal Order is hereby amended by the substitution of the word "me" for the words "the Commissioner of his District".

4. Schedules C. and D. and E. of the Principal Order are hereby amended by the substitution of the words "The Competent Authority" for the words "The Commissioner,District," whenever they occur in each Schedule respectively.

**THE EMERGENCY POWERS (CYPRUS DEFENCE)
REGULATIONS, 1939.**

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939, I hereby order as follows:—

1. This Order may be cited as the Defence (Regulation of Sale Prices) (Kerosene) Amendment (No. 2) Order, 1939, and shall be read as one with the Defence (Regulation of Sale Prices) (Kerosene) Orders, 1939, (hereinafter called "the Principal Order"), and the Principal Order and this Order may together be cited as the Defence (Regulation of Sale Prices) (Kerosene) Orders, 1939 to (No. 2) 1939.

2. The Schedule to the Principal Order is hereby repealed and the following Schedule substituted therefor:—
