THE EMERGENCY POWERS (CYPRUS DEFENCE) REGULATIONS, 1939.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 43.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 43 of the Emergency Powers (Cyprus Defence) Regulations, 1939,

I hereby order as follows:—

1. This Order may be cited as the Defence (Regulation of Sale Prices) (Local Olive Oil) Amendment Order, 1939, and shall be read as one with the Defence (Regulation of Sale Prices) (Local Olive Oil) Order, 1939, (hereinafter called "the Principal Order"), and the Principal Order and this Order may together be cited as the Defence (Regulation of Sale Prices) (Local Olive Oil) Orders, 1939.

2. Clause 2 of the Principal Order is hereby repealed and the following

clause is substituted therefor:—

"2. No person shall—

(a) sell or purchase by retail, or

(b) offer for sale or attempt to sell or purchase by retail, or

(c) either directly or indirectly make any arrangement for the

sale or purchase by retail of, any local olive oil of the kind described in column (1) of the Schedule hereto in any of the towns or villages in the Colony at a price in excess of the retail price shown in column (2) of the said Schedule opposite the kind of such local olive oil."

3. Clause 3 of the Principal Order is hereby repealed and the following

clause is substituted therefor:—

"3. No person shall—

(a) sell or purchase by wholesale, or

(b) offer for sale or attempt to sell or purchase by wholesale, or

(c) either directly or indirectly make any arrangement for the

sale or purchase by wholesale of, any local olive oil of the kind described in column (1) of the Schedule hereto in any of the towns or villages in the Colony at a price in excess of the wholesale price shown in column (3) of the said Schedule opposite the kind of such local olive oil."

4. The following clause shall be inserted in the Principal Order

immediately after clause 9 thereof:-

"9a. For the purposes of this Order "Grade A" local olive oil means local olive oil which is not less than four months old, which has an acidity of less than 2%, which has been filtered and which is sold or offered for sale in clean, sealed bottles."

5. The Schedule to the Principal Order is hereby repealed and the

following Schedule is substituted therefor:-
