In exercise of the powers vested in him by section 6 of the Municipal Corporations Laws, 1930 to 1938, His Excellency the Governor has been pleased to order and hereby orders that the Notice made under the said section, dated the 30th day of December, 1938, and published in the *Gazette* of the 31st day of December, 1938, shall be and is hereby amended by the deletion of the words "1st day of January, 1940," appearing therein and the substitution therefor of the words "1st day of January, 1941,".

## THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

## ORDER MADE UNDER SECTION 13.

*Governor.*

Whereas at a meeting duly convened and held at the village of Mora, in the District of Nicosia, on the 11th day of August, 1939, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Mora.

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Mora has forwarded to the Commissioner of the District of Nicosia a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor considers it expedient, having regard to all the circumstances, that the area in the said report described should be reserved as the Tree Planting Area of the village of Mora :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows:—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Mora, in the District of Nicosia.

SCHEDULE.

The area lying within the following boundaries, that is to say:—

The boundary commences at the north-western corner of plot No. 88 of the Government Survey Plan No. XXII/38, locality "Koumsal," on a footpath from the village of Mora to the village of Angastina, and proceeds south-eastwards along the boundaries of, and including, plots Nos. 88, 94, 95, 96, 102 and 104 of the said plan to the most northern point of plot No. 104 of the said plan, on the left bank of the river "Pedieos"; thence south-westwards along the left bank of the said river to the south-eastern corner of plot No. 17 of the Government Survey Plan No. XXII/46; thence southwards in a straight line across the said river to the most western point of plot No. 56 of the said plan, on the right bank of the said river; thence south-eastwards along the eastern boundary of plot No. 19 of the said plan to the south-eastern corner of the latter plot, locality "Bostanlik," on a road from the village of Mora to the "Mania" Chiftlik; thence westwards along this road to the south-western corner of plot No. 22 of the said plan, locality "Lourin"; thence north-westwards along the boundaries of, and including, plots Nos. 22, 24 and 25 of the said plan to the most western point of plot No. 25 of the said plan, on the footpath from the village of Mora to the village of Angastina; thence north-eastwards along the said footpath to the right bank of the river "Pedieos"; thence south-westwards along the right bank of the said river to the north-eastern corner of plot No. 217 of the Government Survey Plan No. XXII/45, locality "Zeitun Tarlasi"; thence southwards and westwards along the boundaries of, and including, plots Nos. 217 and 218 of the said plan to the south-western corner of plot No. 218 of the said plan, on the road from the village of Mora to the village of Angastina; thence northwards along the said road to the north-western corner of plot No. 209 of the said plan; thence eastwards and southwards along the boundaries of, and including, plots Nos. 209, 214 and 215 of the said plan to the south-eastern corner of plot No. 215 of the said plan, on the left bank of the river "Pedieos"; thence north-eastwards along the left bank of the said river to the most eastern point of plot No. 1 of the Government Survey Plan No. XXII/46; thence westwards and northwards along the southern, western and northern boundaries of plot No. 3 of the said plan to the north-eastern corner of the said plot, on the footpath from the village of Mora to the village of Angastina; thence north-eastwards along the said footpath to the point of commencement; all which said area is 260 donums or thereabouts, as shown edged in blue on the plan filed in D.L.R.S. M.P. 677/38.
