Rule 70. Every owner or lessee or occupier of any premises constructed after the publication of these rules within the area of the village shall, to the satisfaction of the Medical Officer, provide such premises with proper and sufficient sanitary conveniences and maintain the same in a sanitary condition.

Rule 71. Every owner or lessee or occupier of any premises constructed after the publication of these rules within the area of the village shall, to the satisfaction of the Medical Officer—

(a) provide such premises with a proper waste water sump, and

(b) keep every such waste water sump in a thoroughly good and sanitary condition.

Rule 94. No meeting of the Village Health Commission shall be valid unless at least six members thereof are present.

## No. 49. The Public Health (Villages) Laws, 1936 to 1938.

Rules made by the Village Health Commission of Mesa Khorio under Section 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1938, the Village Health Commission of Mesa Khorio hereby make the following Rules:—

1. These Rules may be cited as the Village Health (Mesa Khorio) Rules, 1939, and shall come into operation on their publication in the Gazette.

### No. 50. The Public Health (Villages) Laws, 1936 to 1938.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF MESOYI-TRIMITHOUSA (PAPHOS) UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1938, the Village Health Commission of Mesoyi-Trimithousa (Paphos) hereby make the following Rules:—

- 1. These Rules may be cited as the Village Health (Mesoyi-Trimithousa (Paphos)) Rules, 1939, and shall come into operation on their publication in the Gazette.
- 2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Karavostasi) Rules, 1938, published in the Gazette of 4th March, 1938, shall:—
  - (a) be deemed to be rules made by the Village Health Commission of Mesoyi-Trimithousa (Paphos) and to be incorporated herein, and

(b) apply to the village of Mesoyi-Trimithousa (Paphos).

- (2) The Rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Karavostasi) Rules, 1938.
- (3) Those rules of the Village Health (Karavostasi) Rules, 1938, mentioned in Part II of the Schedule hereto, shall not apply to the village of Mesoyi-Trimithousa (Paphos).

"Medical Officer" means the District Medical Officer of Paphos or his representative and includes any registered Medical Practitioner or other person authorized or appointed by the Director of Medical Services for the purposes of these Rules.
