No. 436. THE DEFENCE REGULATIONS, 1940 TO (No. 3) 1940.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of Regulation 61 of the Defence Regulations, 1940 to (No. 3) 1940, I hereby order as follows:—

1. This Order may be cited as the Defence (Control of Weekly Sales of Sugar) Order, 1940, and shall come into operation on the date of its publication in the Gazette.

2. For the purposes of this Order—
"head of household" means, in the case of a dwelling-house, the head or the person acting as the head of the household, and in the case of any hotel or boarding house the keeper or manager of such hotel or boarding house.

3. Except under my written permission or under the written permission of the Commissioner of the District, and notwithstanding anything contained in any other order made by me, no person shall—

(a) buy, or(b) sell to any one person,

during any one week a quantity of sugar in excess of 50 drams:

Provided that heads of households may make purchases of sugar on behalf of members of their households within the limit specified above.

- 4. Save as provided in Clause 3 of this Order, no retailer shall sell or supply sugar to any person unless such person is registered with such retailer as a registered householder.
- 5. Any householder desiring to purchase sugar shall make application therefor to a retailer, completing and delivering to such retailer a declaration containing the particulars set forth in the Schedule hereto and thereupon such retailer, unless I shall otherwise direct, shall register such householder in a book provided by me for such purpose (hereinafter called "Registration Book") and shall allot to each householder a serial or distinctive number:

Provided that householders registered under the repealed Defence (Specified Foodstuffs) Registration of Householders Order, 1940, shall be deemed to have been registered under this Order.

- 6. Except with my consent in writing no householder shall apply for registration to, nor shall be registered with, more than one retailer at any one time.
- 7. If a registered householder desires to obtain his purchases or supplies of sugar from a retailer other than the retailer with whom such householder is registered for the time being, he must give notice therefor in writing-
 - (a) to the retailer with whom such householder was registered, whereupon such retailer shall delete the name of such householder from the
 - Registration Book; and
 (b) to the Mukhtar of the village or of the quarter of the town or village in which such retailer carries on business, whereupon such Mukhtar shall give to such householder a certificate to the effect that the name of such householder has ceased to be on the Registration Book.

The certificate of the Mukhtar under paragraph (b) hereof shall be sufficient authority for the registration of the householder concerned with another retailer.

- 8. Every retailer shall keep such books for recording sales as I may from time to time direct.
- 9. I may appoint Inspectors and the Commissioner of each District shall, if so required by me, appoint Inspectors to ascertain whether the provisions of this Order have been, or are being, complied with.

10. Any person who-

(a) acts in contravention of this Order, or

(b) gives, in any declaration made under Clause 5 of this Order, any particular which is false,

is liable to the penalties prescribed in Regulation 94 of the Defence Regulations, 1940 to (No. 3) 1940.
