## THE TREE PLANTING VILLAGE AREAS LAWS, 1930 TO 1936.

## ORDER MADE UNDER SECTION 13.

Whereas at a meeting duly convened and held at the village of Ayios Yeoryios, in the District of Limassol, on the 14th day of May, 1939, it was determined by the requisite majority of the voters present thereat that a certain area should be reserved as the Tree Planting Area of the village of Ayios Yeoryios :

And whereas at the said meeting the boundaries of the said area have been fixed and described :

And whereas the Mukhtar of the village of Ayios Yeoryios has forwarded to the Commissioner of the District of Limassol a report, signed and sealed by him, containing a description with boundaries of the said area and stating that the said area fulfils the conditions in section 10 (4) of the Tree Planting Village Areas Laws, 1930 to 1936, prescribed :

And whereas the said Commissioner has transmitted the said report, together with his recommendations, to the Colonial Secretary for the consideration of the Governor :

And whereas the Governor has decided to limit the area in the said report described :

Now, therefore, His Excellency the Governor, in exercise of the powers vested in him by section 13 of the Tree Planting Village Areas Laws, 1930 to 1936, is pleased to order and it is hereby ordered as follows :—

The area described in the Schedule hereto is hereby declared to be and shall be reserved as the Tree Planting Area of the village of Ayios Yeoryios, in the District of Limassol.

## SCHEDULE.

The area lying within the following boundaries, that is to say :—

The boundary commences at the north-western corner of plot No. 1065 of the Government Survey Plan No. XLVII/52, locality "Mousaes," on the right bank of a stream, which point is on the boundary of the village of Ayios Yeoryios, and proceeds north-eastwards along the right bank of the said stream to the footpath at the most northern point of plot No. 937 of the Government Survey Plan No. XLVII/44 ; thence south-eastwards along the said footpath to the most northern point of plot No. 120 of the Government Survey Plan No. XLVII/53, locality "Parambela" ; thence south-eastwards along the boundaries of, and including, plots Nos. 120, 122, 124 and 112 of the said plan, to the north-eastern corner of the last-mentioned plot, locality "Petroudhia," on a footpath ; thence south-eastwards along the said footpath to the south-western corner of plot No. 181 of the said plan ; thence north-eastwards along the boundaries of, and including, plots Nos. 181, 154 and 155 of the said plan, locality "Kapsalia," to the most northern point of the last-mentioned plot, on the right bank of the river "Kouris," which point is on the boundary of the village of Ayios Yeoryios ; thence southwards along the said village boundary to the most eastern point of plot No. 87 of the Government Survey Plan No. XLVII/61,

locality "Stirakas," on a stream ; thence north-westwards along the left bank of the said stream to the most northern point of plot No. 1153 of the Government Survey Plan No. XLVII/52, on the boundary of the village of Ayios Yeoryios ; thence northwards along the said village boundary to the point of commencement ; all which said area is 1,070 donums or thereabouts, as shewn edged in red on the plan filed in D.L.R.S. M.P. 360/39.

## **No. 58. THE CUSTOMS LAWS, 1936 TO 1939.**

### **NOTIFICATION UNDER SECTION 66.**
