

No. 17. THE MUNICIPAL CORPORATIONS LAWS, 1930 TO 1941.

ORDER IN COUNCIL No. 2037

MADE UNDER SECTION 116 (a) (i).

I, the Governor in Council, in exercise of the powers conferred by section 116 (a) (i) of the Municipal Corporations Laws, 1930 to 1941, and of every other power vested in me in that behalf, do hereby order as follows :—

1. Clause 1 of the Order in Council No. 1979 published in the *Gazette* of the 18th December, 1940, is hereby amended—

(a) by the deletion in paragraph (c) (i) of the figures “£3,000” and the substitution thereof of the figures “£3,726.3.6”;

(b) by the deletion in paragraph (c) (iii) of the figures “£2,000” and the substitution thereof of the figures “£1,376.11.7”.

2. The Order in Council No. 2006 published in the *Gazette* of the 31st December, 1941, is hereby amended by the deletion in paragraph (c) (ii) of the figures “£1,000” and the substitution thereof of the figures “£897.4.5”.

No. 18. THE POST OFFICE LAWS, 1881 TO 1933.

ORDER IN COUNCIL No. 2038

MADE UNDER SECTION 6.

C. C. WOOLLEY,
Governor.

I, the Governor in Council, in exercise of the powers conferred by section 6 of the Post Office Laws, 1881 to 1933, do hereby order as follows :—

1. This Order may be cited as the Post Office (Air Mail Rate of Postage) Order, 1942.

2. There shall be charged a combined Postage and Air fee, in addition to late and/or registration fees, at the rates set forth in the second and third columns of the Schedule hereto, on letters, printed papers, commercial papers, samples, small packets and postcards intended for transmission by air mail to any of the countries of destination enumerated in the first column of the said Schedule, such transmission to be effected—

(a) by surface route from the Colony to Egypt; and

(b) from Egypt to the country of destination either wholly by air or partially by air and partially by surface route.

3. The Post Office (Air Mail Rate of Postage) Order, 1941, is hereby revoked.
