SUBSIDIARY LEGISLATION.

No. 386. THE EMERGENCY POWERS (DEFENCE) ACTS, 1939 AND 1940.

REGULATIONS MADE BY THE GOVERNOR.

I, the Governor, in exercise of the powers conferred by the Emergency Powers (Defence) Acts, 1939 and 1940, as extended to the Colony by the Emergency Powers (Colonial Defence) Order in Council, 1939, and the Emergency Powers (Colonial Defence) (Amendment) Order in Council, 1940, do hereby make the following regulations:—

1.—(1) These regulations may be cited as the Defence (Appointment of Special (Defence) Constables) Regulations, 1942.

(2) The Interpretation Law, 1935, shall apply to the interpretation of these regulations as it applies to the interpretation of a Law. 26 of 1935

2. Notwithstanding anything in any Law contained the Commissioner of each District may, with the approval of the Governor, appoint within his District Special (Defence) Constables for the purpose of watching and protecting military property in the District.

3. Special (Defence) Constables appointed under the provisions of these regulations—

- (a) shall be under the control of the Commissioner of the District;
- (b) shall be paid such wages or remuneration as the Governor may approve;
- (c) shall have the same powers, privileges and protection, and be liable to the same duties and penalties as members of the Cyprus Police Force.

No. 387. THE DEFENCE REGULATIONS, 1940 TO (No. 8) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 8) 1942, I hereby order as follows:—

1. This Order may be cited as the Defence (Soap Manufacturers Control) Order, 1942.

2. In this Order—

“soap” means soap of all kinds;

“soap manufacturer” means any person who owns or controls any factory or premises wherein soap is manufactured.

3.—(a) From and after the 19th October, 1942, no person shall carry on the business of a soap manufacturer save under a special permit issued under my hand.

(b) Every special permit issued under the provisions of paragraph (a) hereof may contain such terms and conditions (including the quantity

and description of soap to be produced and the price at which such soap may be sold or purchased) as may be specified therein.

4. Every person engaged in the manufacture of soap shall—

- (a) keep in his premises such books and records as I may direct ;
- (b) not later than seven days after the last day of each month, commencing from the month of October, 1942, complete and deliver to me a return in the form of, and containing the particulars set out in, the Schedule to this Order.

5. No soap manufacturer shall in the manufacture of soap use or cause to be used any edible oil or fat or any admixture of any edible oil or edible fat.

6. Every person shall permit such person as I or the Commissioner of the District may authorize by writing in that behalf, to enter upon and inspect his premises for the purpose of ascertaining whether the provisions of this Order have been or are being complied with, or for the purpose of checking the correctness or accuracy of any return made by such person under any of the provisions of this Order.

7. Any person who—

- (a) contravenes or fails to comply with any of the provisions of this Order ;
- (b) makes any return required to be made under this Order which is false in any material particular ;
- (c) fails to comply with any condition in any permit issued under this Order ;
- (d) knowingly misleads or otherwise interferes with or impedes any person exercising any powers or performing any duties under the provisions of this Order ;

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 8) 1942.
