## THE DEFENCE REGULATIONS, 1940 TO (No. 9) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 9) 1942, I hereby order as follows :

1. This Order may be cited as the Defence (Bakery and Bread) (Amendment) (No. 3) Order, 1942, and shall be read as one with the Defence (Bakery and Bread) Orders, 1942, (hereinafter referred to as "the principal Order") and the principal Order and this Order may together be cited as the Defence (Bakery and Bread) Orders, 1942 to (No. 3) 1942.

2. Clause 5 of the principal Order is hereby deleted and the following clause substituted therefor :—

"5.—(1) No person—

- (a) shall prepare, make or bake bread for sale whether by retail or wholesale, except at the bakery of a registered baker ;
- (b) shall prepare, make or bake bread for sale other than from an admixture of imported flour or whole wheat flour and of barley flour, in the proportions specified in sub-clause (2) of this clause ;
- (c) shall sell or offer for sale or expose for sale any bread, except bread prepared, made or baked from an admixture of imported flour or whole wheat flour and of barley flour, in the proportions specified in sub-clause (2) of this clause.

(2) The admixture referred to in sub-clause (1) of this clause shall contain for every 75 oke of imported flour or whole wheat flour or of both 17 oke of barley flour."

## THE DEFENCE REGULATIONS, 1940 TO (No. 9) 1942.

ORDER MADE BY THE COMPETENT AUTHORITY UNDER REGULATION 61.

In exercise of the powers vested in me by virtue of my appointment by the Governor as the Competent Authority for the purposes of regulation 61 of the Defence Regulations, 1940 to (No. 9) 1942, I hereby order as follows :—

1. This Order may be cited as the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Amendment (No. 3) Order, 1942, and shall be read as one with the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Orders, 1941 to (No. 2) 1942 (hereinafter called the "principal Order") and the principal Order and this Order may together be cited as the Defence (Returns of Stocks of Essential Engineering and Building Construction Materials) Orders, 1941 to (No. 3) 1942.

2. Clause 3 of the principal Order is hereby deleted and the following substituted therefor :—

"3.—(1) Every person selling, whether by wholesale or retail, any of the articles described in the First Schedule hereto shall :—

(a) keep on his premises—

- (i) a "Purchase Record Book" in the Form set forth in the Fourth Schedule hereto, the pages of which shall be numbered consecutively, and
- (ii) a "Sales Record Book" in the Form set forth in the Fifth Schedule hereto the pages of which shall be numbered consecutively,

wherein he shall enter or cause to be entered the particulars set forth in the Fourth and Fifth Schedules hereto respectively,

- (b) submit within two days after the last day of each month to the Director of Public Works at Nicosia a monthly return in the Form set forth in the Third Schedule hereto, and shall submit such return monthly.

(2) The provisions of this clause shall apply *mutatis mutandis* to any person who disposes of any of the articles to which this Order applies otherwise than by sale."

3. Clause 5 of the principal Order is hereby deleted and the following substituted therefor :—

"5. Any person who—

- (a) acts in contravention of, or fails to comply with, any of the provisions of this Order, or

- (b) makes or causes to be made in any book kept under clause 3 of this Order any entry which is false in any material particular, or

- (c) makes under any of the provisions of this Order a return or declaration which is false in any material particular,

is liable to the penalties prescribed in regulation 94 of the Defence Regulations, 1940 to (No. 9) 1942."

6. The principal Order is hereby amended by the addition thereto immediately after the Third Schedule, of the following Schedules :—
