SCHEDULE.

Area situated within the lands of the village of—

1. Xylotymbou in the District of Larnaca:

Commencing at a point 12 feet east of Forest Cairn No. 3 of Xvlotymbou Forest, the boundary proceeds eastwards a distance of 900 feet approximately to Forest Cairn No.2; thence southerly a distance of 320 feet approximately; thence westerly a distance of 900 feet approximately to a point 12 feet east of Forest Cairn No. 4; thence northerly a distance of 320 feet approximately to point of commencement. The extent of the area is 20 donums approximately and lies within Government Survey Plan XLL13 E & W.

2. Ormidhia in the District of Larnaca:

Commencing at Forest Cairn No. 1 of Xylotymbou Forest, the boundary of the area proceeds north-easterly in a straight line to Forest
