THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 AND 1944.

In pursuance of the provisions of section 19 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, the following rules made by the Committee of the Irrigation Division of Phini (Diorizos Water), in the district of Limassol, are published in the Gazette.

IRRIGATION DIVISION OF PHINI (DIORIZOS WATER).

Rules.

1. These rules may be cited as the Irrigation Division of Phini (Diorizos Water) (Amendment) Rules, 1945, and shall be read as one with the Irrigation Division of Phini (Diorizos Water) Rules, 1934 (hereinafter Gazette: referred to as "the principal Rules"), and the principal Rules and these 12.10.1934. rules may together be cited as the Irrigation Division of Phini (Diorizos Water) Rules, 1934 and 1945.

2. Rule 5 of the principal Rules is hereby amended by the deletion therefrom of the words "five shillings" (line 2) and the substitution

therefor of the words "twenty-five shillings".
