THE AGRICULTURAL DEBTORS RELIEF LAWS, 1940 TO 1945.

NOTIFICATION UNDER SECTION 3 (1).

It is hereby notified that in exercise of the powers conferred on the Governor by section 3 (1) of the Agricultural Debtors Relief Laws, 1940 to 1945, and of every other power thereunto enabling, His Excellency the Acting Governor has been pleased to order that the Debt Settlement Board established by Notification published under No. 190 in Supplement No. 3 to the *Gazette* of the 20th May, 1940, shall be dissolved and shall cease to function as from the 1st November, 1945.
