# THE AGRICULTURAL PRODUCE (EXPORT) LAW, 1933.

## REGULATIONS MADE UNDER SECTION 8.

C. C. WOOLLEY,  
Governor.

I, the Governor in Council, in exercise of the powers conferred by section 8 of the Agricultural Produce (Export) Law, 1933, do hereby make the following regulations:—

1. These regulations may be cited as the Agricultural Produce (Dried Figs) Export Regulations, 1946.

2. In these regulations—

"dried figs" means the dried fruit of the plant *Ficus carica*.

"Law" means the Agricultural Produce (Export) Law, 1933.

"inspector" means the produce inspector for the place of inspection at which the dried figs intended for export are submitted for examination.

3.—(1) Any person who intends to export any dried figs shall give notice to the inspector at the place of exportation at least three clear days before the proposed date of exportation stating the quantity of dried figs to be shipped.

(2) The consignment shall be presented for examination sufficiently in advance of the date on which it is proposed to ship the dried figs to permit the examination to be carried out in daylight.

(3) The consignment shall be stacked at a place of inspection approved by the Director of Agriculture and in such manner as the inspector may direct for the purpose of facilitating and expediting the inspection and grading.

4. The inspector shall open and inspect not less than 10 per centum of the boxes from every consignment and shall classify the consignment as "FANCY GRADE", "SELECTED GRADE" or "COMMERCIAL GRADE" dried figs, or as unfit for export.

5. Fancy grade dried figs shall consist of dried figs which—

- (a) are properly pressed and packed in rows and are of a uniform size ;
- (b) are of the same variety and prepared in the same manner in any one box ;
- (c) are properly sorted and are of an even colour and texture and contain—

- (i) not more than 4 per centum of split figs ;
- (ii) no black figs, commonly known as "maxiles" ;
- (iii) no oiled figs, that is to say, figs which have been treated to encourage maturity ;
- (iv) not more than 2 per centum figs which are mechanically damaged ;

(d) are free from mould and extraneous matter ;

(e) are free from insect pests or diseases ;

(f) contain not more than 27 per centum moisture.

6. Selected grade dried figs shall consist of dried figs which—

- (a) are properly pressed and packed in rows ;
- (b) are of the same variety and prepared in the same manner in any one box ;
- (c) are properly sorted and contain :

- (i) not more than 10 per centum split figs ;
- (ii) no black figs, commonly known as "maxiles" ;
- (iii) no oiled figs, that is to say, figs treated to encourage maturity ;
- (iv) not more than 3 per centum figs which are mechanically damaged ;

(d) are free from mould and extraneous matter ;

(e) are free from insect pests and diseases ;

(f) contain not more than 27 per centum moisture :

7. Commercial grade dried figs shall consist of dried figs which—

- (a) are properly pressed and packed in rows ;
- (b) are of the same variety and prepared in the same manner in any one box ;
- (c) are properly sorted and contain :

- (i) not more than 15 per centum split figs ;
- (ii) no black figs, commonly known as "maxiles" ;
- (iii) not more than 5 per centum figs which are mechanically damaged ;

(d) are free from mould and extraneous matter ;

(e) are free from insect pests and diseases ;

(f) contain not more than 27 per centum moisture.

Provided that dried figs which do not comply with sub-paragraph (i) of paragraph (c) of this regulation may be passed as fit for export if specially packed by splitting them open and pressing each two figs together.

8. The inspector shall, upon passing a consignment as fit for export and classifying the same, stamp on each box thereof the words "Passed for Export Fancy Grade", "Passed for Export Selected Grade" or "Passed for Export Commercial Grade", as the case may be.

P. 475. 9. All dried figs for export shall be packed in new wooden boxes of size  $45 \times 38 \times 14$  cms. or  $37 \times 25 \times 13$  cms., which are planed inside and outside and are covered on the inside with grease or other similar paper:

Provided that dried figs of the same variety may be packed in small packets of cellophane or other similar paper if such packets are packed in boxes of the sizes described above and the number of such packets is clearly marked on such boxes:

Provided further that if the Director of Agriculture is satisfied that the provisions of this regulation cannot be complied with owing to shortage of the materials required therefor, he may permit by writing under his hand the use of such kind of boxes or paper as to him may seem fit.

10. The consignor shall pay to the Collector of Customs at the port of export a fee of 3 piastres for every hundred oke or part thereof of dried figs submitted for examination or re-examination.

11. On presentation of the Customs export specification, the inspector shall enter thereon, in respect of any dried figs which have been passed for export, the amount of fees payable for inspection and shall issue to the shipper a grading slip giving full particulars of the consignment which has been passed for export. The Customs Authorities shall not permit the shipment of any dried figs unless the relative grading slip has been produced to them.

12. The inspector shall issue to the shipper in respect of any dried figs which have been passed for export a certificate in the form set out in the Schedule hereto.

13. Dried figs which have not been passed by the inspector shall be removed from the place of inspection within 24 hours of the notification by the inspector of his refusal to pass such dried figs for export.

14. Each place of inspection shall be in all respects under the control of the inspector in charge of it and, with the exception of any shipper whose consignment is undergoing inspection, no member of the public shall have access to it without the express permission of the inspector.

15. Notwithstanding anything in these regulations contained, the Director of Agriculture may, by a permit in writing under his hand and subject to such conditions as may be specified in such permit, allow the shipment of dried figs which do not conform to these regulations.

16. Nothing in these regulations shall apply to dried figs not exceeding three pounds in weight exported through the post.

17. These regulations shall come into operation on the 1st day of May, 1946, and thereupon the Agricultural Produce (Dried Figs) Regulations, 1944 to (No. 1) 1944, shall be repealed without prejudice to anything done or left undone thereunder.

### THE FOREST LAW, 1939.

#### GRANT MADE UNDER SECTION 5.

C. C. WOOLLEY,

Whereas by a grant given under my hand and the Public Seal of the Colony at Nicosia on the 31st day of May, 1944, the land described in the Schedule thereto has been granted to Tofi Christofi of Ayios Merkourios under the terms and conditions embodied therein ;

And whereas the said Tofi Christofi of Ayios Merkourios has now applied to the Governor praying that the aforesaid land be granted to his grand-daughter Eleni Christodoulou of Ayios Merkourios ;

Now, therefore, I, Charles Campbell Woolley, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Officer of the Most Excellent Order of the British Empire, upon whom has been conferred the decoration of the Military Cross, Governor and Commander-in-Chief in and over the Colony of Cyprus, do hereby revoke the aforesaid grant unto the name of Tofi Christofi of Ayios Merkourios in respect of the aforesaid land and do hereby grant unto Eleni Christodoulou of Ayios Merkourios her heirs and successors the land described in the Schedule hereto situated in the Main State Forest referred to in the Order in Council mentioned in the second column of the Schedule hereto on condition that the grantee shall not be registered therefor or mortgage, sell or in any other way dispose of the same except with the consent of the Governor previously obtained.
