**THE DEFENCE (CONTROL OF FUEL AND CHARCOAL)  
ORDER, 1944.**

**NOTICE No. 4 UNDER CLAUSE 10.**

The Second Schedule to the above Order is hereby amended by the deletion from Part 3 thereof of the whole of Part A (relating to prices of charcoal) and the substitution therefor of the following Part:—

**"A.—CHARCOAL:**
