

**No. 69. THE LAND ACQUISITION LAWS, 1899 TO 1945.****NOTICE UNDER SECTION 5.**

Notice is hereby given that the lands described below being the site of a military camp at the localities "Kolokoshi", "Bernera", "Mandroudhia", "Palloura" and "Bernia", of an approximate total extent of 299 donums, including all privately owned structures, wells, running water and trees standing thereon, situated within the limits of the village of Ayios Dhometios village are required by the Governor for an undertaking of public utility:—

**No. 70. The Irrigation Divisions (Villages) Laws, 1938 and 1944.**

**IRRIGATION DIVISION OF POTAMIOU.***Rules.*

1. These rules may be cited as the Irrigation Division of Potamiou Rules, 1947.

2. In these rules, unless the context otherwise requires—

"Commissioner" means the Commissioner of the District of Limassol;

"Committee" means the Committee of the Irrigation Division;
