THE CUSTOMS LAWS, 1936 TO (No. 2) 1948, AND THE
CUSTOMS HOUSES (DAYS AND HOURS OF BUSINESS)
ORDERS, 1943 TO 1947.

OVERTIME WORK.

In virtue of the powers vested in the Comptroller by section 6 (4) of the Customs Laws, 1936 to (No. 2) 1948, I hereby prescribe that from and after the 1st May, 1948, overtime at the rates prescribed in the Schedule hereto shall be charged for the services of Customs Officers where permitted to carry out overtime work under the Customs Houses (Days and Hours of Business) Orders, 1943 to 1947 :

Provided that where the services are rendered for overtime work in respect of two or more vessels working at the same time, the overtime charges shall be divided or apportioned between such vessels in such manner or in such proportion as the Collector may direct.

2. Notification No. 267 published in Supplement No. 3 to the *Gazette* of the 29th September, 1939, is cancelled as from the 1st May, 1948.
