

No. 231. THE GAME AND WILD BIRDS LAWS, 1934 TO 1947.**ORDER MADE UNDER SECTION 6.**

In exercise of the powers vested in me by section 6 of the Game and Wild Birds Laws, 1934 to 1947, I, the Governor, do hereby order as follows :—

1. This Order may be cited as the Game and Wild Birds (Close Season Extension) Order, 1948.

2. The shooting, killing, taking, pursuing or selling of any game or wild bird during the period between 1st October, 1948, and the 31st January, 1949, both days inclusive, is hereby prohibited and the said period shall be deemed to be a Close Season for all purposes of the said Laws.

3. This Order has effect in addition to the provisions of the Game and Wild Birds Laws, 1934 to 1947, relating to the Close Season as defined in the said Laws.

No. 232. THE HOTELS LAWS, 1935 TO 1943.**REGULATIONS MADE UNDER SECTION 12.**

In exercise of the powers vested in me by section 12 of the Hotels Laws, 1935 to 1943, I, the Governor, with the advice of the Executive Council, do hereby make the following regulations :—

1. These regulations may be cited as the Hotels (Amendment) Regulations, 1948, and shall be read as one with the Hotels Regulations, 1935 to 1946 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Hotels Regulations, 1935 to 1948.

2. Regulation 1A of the principal Regulations (as set out in Supplement No. 3 to the *Gazettes* in the margin hereto) is hereby amended as follows :—

- (a) by the insertion immediately after the definition "boarding terms" of the words "or full board";
- (b) by the insertion therein at the end thereof of the following definitions :—

"'camp hotel' means a Summer Resort Hotel carrying on business in tents and/or huts or partly in a building and partly in tents and/or huts and references to a hotel-keeper shall include a camp hotel-keeper ;

'Inspector' means any person appointed by the Hotels Board to be an inspector for the purposes of these regulations."

3. The principal Regulations are hereby amended by the insertion therein, immediately after regulation 7, of the following regulation :—

"7A.—(1) Any Inspector acting in the course of his duties as such may, with a view to securing compliance with the provisions of these regulations—

- (a) at any time enter and inspect any hotel or camp hotel ;

- (b) require any hotel-keeper or any of his employees, servants or agents to produce to him any books of accounts or other documents or any article or thing relating to the business of the hotel or camp hotel ;
 - (c) investigate any matter arising out of the provisions of these regulations which, in his opinion, requires investigation ;
 - (d) interrogate any person whom he finds in any hotel or camp hotel or whom he believes to be employed or to have been employed in such hotel or camp hotel, with respect to any of the matters dealt with in these regulations ;
 - (e) seize and detain any books of accounts or other documents or any article or thing relating to the business of any hotel or camp hotel if he suspects that they contain evidence of commission of a contravention of the provisions of these regulations.
- (2) No person shall—
- (a) prevent, obstruct, hinder or impede any Inspector in the exercise of his powers and duties under these regulations ;
 - (b) refuse or fail to produce any book, account or document or any article or thing relating to the business of any hotel or camp hotel on demand being made by any Inspector for such production ;
 - (c) refuse or fail to answer to the best of his knowledge and belief any question which any Inspector in the exercise of his powers under these regulations may put to him."
4. The principal Regulations are hereby amended by the deletion therefrom of regulation 10 and the substitution therefor of the following regulation :—
- " 10. Any person who acts in contravention of, or fails to observe, any of the provisions of these regulations shall be liable to a fine not exceeding fifty pounds and, if the offender is a hotel-keeper, the court trying the offence may, upon conviction, in addition to such fine, order the cancellation of his licence."

No. 233. THE LAND ACQUISITION LAWS, 1899 TO 1947.

NOTIFICATION UNDER SECTION 6.

In exercise of the powers vested in me by section 6 of the Land Acquisition Laws, 1899 to 1947, and with reference to the Notification dated the 15th day of December, 1947, and published under No. 393 in Supplement No. 3 to the *Gazette* of the 18th December, 1947, relating to certain lands on which the Military Authorities constructed a military road, situated in the town of Kato Paphos, in the District of Paphos, I, the Governor, do hereby sanction the acquisition, under the provisions of the aforesaid Laws, of the immovable properties situated in the town of Kato Paphos, particulars whereof are specifically set out in the notice of the Commissioner, Paphos, published under Notification No. 88, in Supplement No. 3 to the *Gazette* of the 4th March, 1948, to vest and be registered in the name of the Government.
