With reference to the Notification published under No. 389 in Supplement No. 3 to the *Gazette* No. 3343 of 18th December, 1947, notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned in that Notification.

All that area of land situated in the village of Kythrea in the District of Nicosia comprising  $4\frac{1}{4}$  donums or thereabouts bounded on all sides by private property and including part of plots Nos. 176, 168, 167, 48, 49, 43, 42, 58, 59, 41, 60, 95, of Block "C" Ayia Marina Quarter, Kythrea, part of plots 289, 288, 286, 285, 284, 281, of Block "D" Ayia Marina Quarter, Kythrea, more particularly defined as the area coloured red on the plan marked "Kythrea Bye-Pass" and dated 30th December, 1947, deposited with the Commissioner of Nicosia.

The said area is at present occupied by a bye-pass road constructed by the War Department.

All that area of land situated in the village of Strovolos in the District of Nicosia comprising 22 donums or thereabouts bounded on all sides by private property and including part of plots Nos. 157,

### **THE COMPANIES (LIMITED LIABILITY) LAWS, 1922 TO 1944.**

#### **LICENCE UNDER SECTION 20.**

Whereas it has been proved to the satisfaction of His Excellency the Governor that The Wines and Spirits Association of Cyprus which is about to be registered as a company with limited liability under the Companies (Limited Liability) Laws, 1922 to 1944, is formed for the purpose of promoting objects of the nature contemplated by section 20 (1) of the said Laws, and that it is the intention of the said Association that the income and property thereof whencesoever derived shall be applied solely towards the promotion of the objects of the Association as set forth in the Memorandum of Association of the said Association and that no portion thereof shall be paid or transferred, directly or indirectly, by way of dividend or bonus or otherwise howsoever, by way of profit to its members or to any of them, or to any person claiming through any of them.

Now, therefore, in pursuance of the powers vested in the Governor by section 20 of the Companies (Limited Liability) Laws, 1922 to 1944, and in consideration of the provisions and subject to the conditions contained in the Memorandum of Association of the said The Wines and Spirits Association of Cyprus as subscribed by seven members thereof and approved by the Court on the 13th November, 1947, His Excellency the Governor does by this licence direct The Wines and Spirits Association of Cyprus to be registered as a company with limited liability, without the addition of the word " Limited " to its name.
