THE GAME AND WILD BIRDS LAWS, 1934 TO 1947.

ORDER IN COUNCIL No. 2331

MADE UNDER SECTION 5 (1) (a).

In exercise of the powers vested in me by section 5 (1) (a) of the Game and Wild Birds Laws, 1934 to 1947, I, the Acting Governor, with the advice of the Executive Council, do hereby order that, notwithstanding anything in any other public instrument contained, every holder of a game licence issued under the provisions of the Game and Wild Birds Laws, 1934 to 1947, and subsisting for the time being is hereby authorized to shoot, kill, take or pursue within any of the areas specified in the Schedule to the Game and Wild Birds (Shooting of Wild Birds) Orders, 1937 and 1941, any wild bird between the date of the publication of this Order in the *Gazette* and the 20th day of January, 1949, both days inclusive.

2. This Order shall be in addition to and not in derogation of the Game and Wild Birds (Shooting of Wild Birds) Orders, 1937 and 1941, but shall cease to have effect on and after the 21st January, 1949.
