**No. 91. THE FOREST LAW, 1939 (*Section 10*)
AND
THE LAND ACQUISITION LAWS, 1899 TO 1947.**

NOTIFICATION UNDER SECTION 6.

In exercise of the powers vested in me by section 6 of the Land Acquisition Laws, 1899 to 1947, and with reference to the Notification dated the 9th day of September, 1947, and published under No. 268 in the Supplement No. 3 to the *Gazette* of the 18th September, 1947, relating to the acquisition by the Government of certain immovable properties in the Main State Forest of Adelphi, in the District of Nicosia, in the vicinity of Kapoura Forest Station, I, the Governor, do hereby sanction, under the provisions of the aforesaid Laws, the acquisition of the immovable properties situated within the limits of the village of Kannavia, particulars whereof are specifically set out in the notice of the Commissioner, Nicosia, published under Notification No. 380 in Supplement No. 3 to the *Gazette* of the 4th December, 1947, to vest and be registered in the name of the Government of Cyprus.

THE IRRIGATION DIVISIONS (VILLAGES) LAWS, 1938 AND 1944
(*Section 31*)**

AND

THE LAND ACQUISITION LAWS, 1899 TO 1947 (*Section 5*).

With reference to the Notification published under No. 62 in *Gazette* Supplement No. 3 of the 19th February, 1948, notice is hereby given that the land under plot No. 271/3 of the Government Survey Plan No. XIX.61, situated at Elea village, in the District of Nicosia, at the locality "Veran Dere", comprising $1\frac{1}{4}$ donums or thereabouts and bounded by water channel, river and road, is required by the Irrigation Division of Elea for the construction of a new channel for the conveyance of water by such Division and that the said land has been declared by the Governor, under section 31 of the Irrigation Divisions (Villages) Laws, 1938 and 1944, to be needed for a public purpose.

Any person claiming to have any right or interest in the said land is required within six weeks from the date of this notice to send to me a statement of his right and interest and of the evidence thereof, and of any claim made by him in respect of such right or interest.

The Governor is willing to treat for the acquisition of the said land.

A plan showing the land described above is available for inspection at my office in Nicosia.
