THE PUBLIC HEALTH (VILLAGES) LAWS, 1936 TO 1948.

RULES MADE BY THE VILLAGE HEALTH COMMISSION OF MOUSOULITA UNDER SECTION 9.

In exercise of the powers vested in them by section 9 of the Public Health (Villages) Laws, 1936 to 1948, the Village Health Commission of Mousoulita hereby make the following rules:—

- 1. These rules may be cited as the Village Health (Mousoulita) Rules, 1949, and shall come into operation on their publication in the Gazette.
- 2.—(1) Subject to the provisions of paragraphs (2) and (3) of this rule, the Village Health (Karavostasi) Rules, 1938, published in the Gazette of the 4th March, 1938, shall—
 - (a) be deemed to be rules made by the Village Health Commission of Mousoulita and to be incorporated herein, and
- , (b) apply to the village of Mousoulita.
- (2) The rules set out in Part I of the Schedule hereto shall be substituted for the corresponding rules of the Village Health (Karavostasi) Rules, 1938.
- (3) Those rules of the Village Health (Karavostasi) Rules, 1938, mentioned in Part II of the Schedule hereto, shall not apply to the village of Mousoulita.
