No. 319. THE TREE PLANTING (VILLAGE AREAS) LAW, 1948.

ORDER MADE UNDER SECTION 20.

In exercise of the powers vested in me by section 20 of the Tree Planting (Village Areas) Law, 1948, I do hereby order that the Order relating to the Tree Planting Area of the village of Ayios Mamas, published under Notification No. 966 of the Gazette of the 14th September, 1934, the extension whereof for a further period of five years was published in Supplement No. 3 to the Gazette of 14th September, 1944, and which expires on 14th September, 1949, shall be extended for a further period of five years from the date of expiration as aforesaid.

No. 320. THE TREE PLANTING (VILLAGE AREAS) LAW, 1948.

ORDER MADE UNDER SECTION 12 (2).

In exercise of the powers vested in me by section 12 (2) of the Tree Planting (Village Areas) Law, 1948, I do hereby order that the Order relating to the Tree Planting Area of the village of Alaminos, published in Supplement No. 3 to the *Gazette* No. 2784 of the 13th October, 1939, shall be extended for a further period of ten years.

THE SUMMER RESORTS (DEVELOPMENT) LAWS, 1938 AND 1946.

Bye-laws made by the Summer Resort Development Board for Pano Platres.

In exercise of the powers vested in them by the Summer Resorts (Development) Laws, 1938 and 1946, the Summer Resort Development Board for Pano Platres hereby make the following bye-laws:—

1. These bye-laws may be cited as the Summer Resort Development (Pano Platres) (Amendment No. 2) Bye-laws, 1949, and shall be read as

one with the Summer Resort Development (Pano Platres) Bye-laws, 1938 and 1949 (hereinafter referred to as "the principal Bye-laws"), and the principal Bye-laws and these bye-laws may together be cited as the Summer Resort Development (Pano Platres) Bye-laws, 1938 to (No. 2) 1949.

2. Bye-law 24 of the principal Bye-laws is hereby cancelled and the

following bye-law substituted therefor:-

"24.—(1) Save as in paragraph (3) hereof provided no carcass or fresh meat of any animal shall be brought or kept within the Summer Resort for human consumption or for sale or shall be exposed for sale therein unless—

(a) such carcass or fresh meat belongs to an animal which has been slaughtered at the slaughter-house and has been cleaned and

dressed therein, and

(b) such carcass or fresh meat bears on it the seal in good condition

and well preserved.

- (2) Any carcass or fresh meat found within the Summer Resort, which does not fulfil any of the requirements of this bye-law, may be seized and detained by the Inspector or any other person authorized in writing by the Chairman of the Board, and may be destroyed or otherwise disposed of or dealt with by the written order of the Chairman of the Board.
- (3) The Board may from time to time by public notification allow the bringing into the Summer Resort of any carcass or fresh meat belonging to an animal which has been slaughtered at the slaughter-house of a Municipal Corporation or Summer Resort specified in such public notification subject to such terms and conditions as to the Board may seem fit.
- (4) The Board may at any time by public notification revoke or cancel a public notification made under the preceding paragraph of this bye-law."

The above Bye-laws have been approved by His Excellency the Governor. (M.P. 949/49.)

THE DEFENCE (ANTIBIOTICS CONTROL) ORDER, 1947.

NOTICE No. 2 UNDER CLAUSE 8.

The Schedule is hereby amended by the addition thereto of items 5 and 6 immediately after item 4 to be inserted in the appropriate columns of the said Schedule:—

Name of antibiotic	Description
"5. Chloromycetin.	5. 'Chloromycetin' means any anti-infective substance produced by Streptomyces venezuelae whether obtained from Streptomyces venezuelae or not and any derivative obtained from such substance, and any solution containing any such substance or derivative.
6. Chloromycetin preparation.	6. 'Chloromycetin preparation' means any substance to or into which any chloromycetin has been added or introduced."
