THE TURKISH FAMILY (MARRIAGE AND DIVORCE) LAW, 1951.

RULES MADE UNDER SECTION 50.

A. B. WRIGHT,
Governor.

In exercise of the powers vested in me by section 50 of the Turkish Family (Marriage and Divorce) Law, 1951, I, the Governor, with the advice of the Judges of the Turkish Family Courts, do hereby make the following rules :—

1. These rules may be cited as the Turkish Family (Marriage and Divorce) Rules, 1951.

2. Every marriage officer shall keep a marriage register which shall be numbered consecutively and shall be as in the Form A of the First Appendix hereto.

3. A consent under section 6 of the Law, a notice of marriage under section 11 of the Law, a certificate of notice of marriage under section 14 (1) of the Law and a certificate of marriage under section 14 (3) of the Law shall be as in the Forms B, C, D and E of the Second Appendix hereto, respectively.
