A PROCLAMATION.

Whereas by the Cyprus Laws (New Edition) Law, 1950, provision was made for the preparation of a new and revised edition of the Laws of the Colony as in force on the 31st March, 1949 :

And whereas Sir Harry Herbert Trusted, K.C., was appointed Commissioner for the purpose of preparing the new and revised edition of the Laws of the Colony as aforesaid and such edition has been printed in three volumes (including a volume containing a Chronological Table and Index) by C. F. Roworth Limited, 88 Fetter Lane, London, E.C.4, who are deemed to be the Government printers of the new edition as aforesaid within the meaning of the Evidence (Colonial Status) Act, 1907 :

And whereas the new edition as aforesaid is now completed :

Now, therefore, in exercise of the powers vested in me by section 8 of the Cyprus Laws (New Edition) Law, 1950, I, the Governor, do, by this Proclamation, approve the new edition as aforesaid and order that it shall come into force as from the 1st day of July, 1951.

THE WATER SUPPLY (MUNICIPAL AND OTHER AREAS)
LAW, 1951.

ORDER IN COUNCIL No. 2488

MADE UNDER SECTION 3.

A. B. WRIGHT,

In exercise of the powers vested in me by section 3 of the Water Supply (Municipal and other Areas) Law, 1951, I, the Governor, with the advice of the Executive Council, do hereby declare that, as from the

1st July, 1951, the area set out in the Schedule hereto shall be an area of supply for the purposes of the said Law and do hereby establish for such area a Board consisting of the following persons :—

1. The Commissioner of Nicosia-Kyrenia, as *Chairman* ;
2. The Water Engineer ;
3. The Accountant-General ;
4. Dr. Th. Dervis, Mayor of Nicosia ;
5. Mr. Geo. Poulias, Deputy Mayor of Nicosia ;
6. Dr. Fazil Koutchouk, Municipal Councillor of Nicosia,

to perform the duties and exercise the powers as in the said Law provided.

SCHEDULE.

Area of Supply.

The area lying within the following boundaries, that is to say :—

The boundary commences at the south-western corner of plot No. 216, Block C, Trakhonas village, which corner is on the municipal boundary of Nicosia Town and proceeds eastwards and southwards along the said municipal boundary to its junction with the Nicosia bye-pass ; thence eastwards and south-eastwards along the said bye-pass to its junction with another road coming from the village of Beuyuk Kaimakli, 440 yards approximately south-east of the railway level crossing ; thence southwards in a straight line to milepost No. 1 on the Nicosia (Famagusta Gate)–Larnaca main road ; thence south-eastwards along the said main road to its junction with the forest delimitation line of the Leper Farm Plantation, Minor State Forest ; thence south-westwards along the said delimitation line up to its junction with the Larnaca–Nicosia (Tripoli Bastion new opening) main road ; thence westwards along the said main road to its junction with the Nicosia–Limassol main road ; thence southwards along the last-mentioned main road to its junction with the Athalassa–Strovolos bye-pass ; thence north-westwards along the said bye-pass (but including the Nicosia reservoir site) to its junction with the Nicosia–Palekchori main road ; thence northwards along the said main road to its junction with the road coming from the village of Strovolos, over the bridge, which junction is on the municipal boundary of Nicosia Town ; thence north-westwards and north-eastwards along the said municipal boundary to the point of commencement, all which boundary of the said area of supply is shown edged red on the Government Survey Plan Serial No. 1512.

(NOTE.—The above area of supply includes the limits of the Municipal Corporation of Nicosia and, to that extent, is declared as an area of supply with the consent of the said Municipal Corporation.)
