THE BOMBARDMENT RANGE AREAS LAW. No. 394. CAP. 222 AND LAW 23 OF 1951.

REGULATIONS UNDER SECTION 3.

In exercise of the powers vested in me by section 3 of the Bombardment Range Areas Law, I, the Acting Governor, do hereby make the following Cap. 222 regulations:-

1. These regulations may be cited as the Bombardment Range Areas Gazette: (Amendment) Regulations, 1951, and shall be read as one with the Bom- Suppl. No. 3: bardment Range Areas Regulations, 1949 (hereinafter referred to as "the 11.8.1949 principal Regulations"), and the principal Regulations and these Regulations may together be cited as the Bombardment Range Areas Regulations, 1949 and 1951.

2. The definition "bombardment practice" in regulation 2 of the principal Regulations is hereby deleted and the following substituted therefor:

"' bombardment practice' includes firing of all kinds of ammunition (including rocket projectiles) from any vessel, aircraft, vehicle, artillery weapon, firearm or any other weapon issued for use by His Majesty's Forces or for the dropping of live or other bombs from any aircraft or for

3. The principal Regulations are hereby amended by the insertion therein, immediately after regulation 13, of the following regulations:—

"THE LEFKONIKO BOMBARDMENT RANGE AREA.

14. In this part of the regulations, the 'Lefkoniko Bombardment Range Area.' means the area declared as such under section 2 of the Law by notice to be published in the Gazette or by any other notice amending or substituted for the same.

15. The 'Lefkoniko Bombardment Range Area' shall only be used by day and the signals shall be as follows:-

(i) By a red flag hoisted on the high ground at the SOUTH EASTERN extremity of the area.

(ii) By a red flag hoisted on the high ground one mile WEST SOUTH WEST of the SOUTH EASTERN extremity of the area.

- (iii) By a red flag hoisted on the high ground 3,000 yards WEST SOUTH WEST of the SOUTH EASTERN extremity of the area.
- (iv) By a red flag hoisted on the highest point of the SOUTHERN boundary of the area.
- (v) By a red flag hoisted on the high ground at the SOUTH WESTERN extremity of the area.

(vi) By a red flag hoisted on the WESTERN boundary 2,500 yards NORTH NORTH EAST of the SOUTH WESTERN extremity of the area.

(vii) By a red flag hoisted 700 yards EAST of the centre of the

WESTERN boundary of the area.

(viii) By a red flag hoisted on the WESTERN boundary of the area at a point 900 yards EAST SOUTH EAST of PLATANI.

(ix) By a red flag hoisted at the centre of the NORTHERN boundary

of the area.

(x) By a red flag hoisted on the EASTERN boundary of the area where the track running due SOUTH from MANDRES crosses the boundary.

(xi) By a red flag hoisted 400 yards NORTH WEST of the WESTERN

end of AYIOS IAKOVOS.

(xii) By a red flag hoisted at the centre of the EASTERN boundary

of the area.

(xiii) By a red flag hoisted on the EASTERN boundary 3,000 yards NORTH WEST of the SOUTH EASTERN extremity of the area.

NOTICE UNDER SECTION 2.

I. FLETCHER-COOKE, Acting Governor.

In exercise of the powers vested in me by section 2 of the Bombardment Range Areas Law, I, the Acting Governor, do hereby declare the area set out in the Schedule hereto to be a Bombardment Range Area for the purposes of the aforesaid Law, for a period of twelve calendar months from the date of this notice.

SCHEDULE.

THE LEFKONIKO BOMBARDMENT RANGE AREA,

The boundary commences at the Forest Cairn No. 109 of the "Kantara Main State Forest" and proceeds north-eastwards in a straight line for a distance of 1,430 yards approximately to a point on the map 1: 50,000 Cyprus, Sheet 11, Lefkoniko, by the points Map reference 406880; thence north-eastwards in a straight line for a distance of 2,816 yards approximately to a point on the said map by the points Map reference 431886; thence south-eastwards in a straight line for a distance of 9,064 yards approximately to a point on the said map by the points Map reference 480821; thence south-westwards in a straight line for a distance of 6,295 yards approximately to a point on the said map by the points Map reference 430793; thence north-westwards in a straight line for a distance of 4,224 yards approximately to a point on the said map by the points Map reference 392800; thence north-eastwards in a straight line for a distance of 2,904 yards approximately to a point on the said map by the points Map reference 401824; thence northwards in a straight line to the point of commencement.

All which said boundary is marked more particularly on the ground by Danger Notices situated at prominent points, warning all persons in English, Greek and Turkish that they should keep out of the area when

red flags are hoisted.
