NOTIFICATION UNDER SECTIONS 2, 3 AND 5.

Whereas it has been represented to me that it is desirable in the public interest to align and improve that part of the public road between Nicosia and Famagusta, which is situated between the 3rd and 4th milestones from Famagusta in the District of Famagusta, and that lands are needed for this purpose;

Now, therefore, in exercise of the powers vested in me by section 2 of the Land Acquisition Law, I, the Acting Governor, do hereby declare the alignment and improvement of the aforesaid part of the public road to be an undertaking of public utility and do hereby, by virtue of the powers vested in me by section 3 of the said Law, authorize the carrying out of the said undertaking under the provisions of the said Law and do hereby, by virtue of the powers vested in me by section 5 of the said Law, entrust the Director of Public Works with the supervision and effectuation of the said undertaking.

NOTICE UNDER SECTION 6.

With reference to the Notification published under No. 401 in Supplement No. 3 to the *Gazette* of the 4th October, 1950, notice is hereby given that the following lands are required by the Governor for the undertaking of public utility mentioned therein:—

All that area of private land situated in the village of Eylenja in the District of Nicosia at the locality Platy, comprising 15½ donums, or thereabouts, bounded by private property, Crown land and road and
