CAP. 252 AND LAWS 11 OF 1950 AND 31 OF 1951.

NOTIFICATION UNDER SECTION 129.

Whereas the properties described in the Schedule hereto are required by the Chairman, Deputy Chairman and members of the Municipal Commission and townsmen of Limassol (hereinafter referred to as "the municipal corporation") for the purpose of creating a square in the Turkish Quarter of the town of Limassol within the municipal limits of Limassol;

And whereas the formalities prescribed by sections 127 and 128 of the Municipal Corporations Law have been complied with;

And whereas I, the Governor, have approved the plan submitted in that behalf and consider it expedient, having regard to all the circumstances, that the municipal corporation should be permitted to acquire the said properties for the above public purpose:

Now, therefore, in exercise of the powers vested in me by section 129 of the Municipal Corporations Law, I, the Governor, do hereby sanction the acquisition of the properties described in the Schedule hereto by the municipal corporation.
