# THE VILLAGES (ADMINISTRATION AND IMPROVEMENT) LAW, 1950.

## BYE-LAWS MADE BY THE IMPROVEMENT BOARD OF PEDHOULAS.

In exercise of the powers vested in them by section 24 of the Villages (Administration and Improvement) Law, 1950, the Improvement Board of Pedhoulas hereby make the following bye-laws:—

1. These bye-laws may be cited as the Villages (Administration and Improvement) Pedhoulas (Amendment) Bye-laws, 1953, and shall be read as one with the Villages (Administration and Improvement) Pedhoulas Bye-laws, 1951 (hereinafter referred to as "the principal Bye-laws") and the principal Bye-laws and these bye-laws may together be cited as the Villages (Administration and Improvement) Pedhoulas Bye-laws, 1951 and 1953. *Gazettes:*

2. The principal Bye-laws are hereby amended by the insertion therein and immediately after bye-law 140 of the following bye-laws:—

"140A.—(1) No person shall establish, keep or use or cause to be kept or used within the Improvement Area any tannery unless such person has obtained in every year a licence from the Board and subject to such condition as the Board may deem necessary.

(2) The fee payable for any licence granted under this bye-law shall not exceed £5 per year or part thereof as the Board may in each case determine.

140B.—(1) If upon report by the District Medical Officer the Board is satisfied that a tannery is, or has become injurious to the public health or a public nuisance, the Board may make an order prohibiting the further use of such tannery.

(2) Such order shall take effect as from the date on which a copy thereof signed by the Chairman has been served upon the owner or the person in charge of the tannery."

The above bye-laws have been approved by the Acting Colonial Secretary.
