Whereas by Order in Council No. 2550 published under Notification No. 306 in Supplement No. 3 to the Gazette of the 23rd July, 1952, (hereinafter referred to as "the principal Order") authority was given to the Mayor, Deputy Mayor, Councillors and Townsmen of the Municipal Corporation of Limassol (hereinafter referred to as "the Municipal Corporation") to spend the unexpended balance of £6,210.0.0 specified therein for the purpose of relieving the housing shortage in Limassol town;

And whereas the said authority was given on the condition that the aforesaid balance shall be spent for the construction of twelve workers' houses for the aforesaid purpose and it was found desirable that such specific purpose should be specified in the principal Order;

And whereas by Order in Council No. 2563 published under Notification No. 432 in Supplement No. 3 to the Gazette of the 1st October, 1952, (hereinafter referred to as "the amending Order") the principal Order was accordingly amended to read and have effect as hereinbefore mentioned;

And whereas the construction of the twelve workers' houses has been completed;

And whereas out of the aforesaid sum of £6,210.0.0 there has remained an unexpended balance of $f_{1,451.5.4\frac{1}{2}p}$;

And whereas the Municipal Corporation wishes to utilize the aforesaid balance of $f_{0.1,451.5.4\frac{1}{2}}p$ as a contribution to the Limassol Poor Relief Committee towards the cost of a scheme for establishing an Old Age Hostel in the town of Limassol;

And whereas under section 124 (g) of the Municipal Corporations Law Cap. 252. approval has been given by the Governor that the aforesaid contribution 11 of 1950. should be made:

31 of 1951. 20 of 1953.

Now, therefore, in exercise of the powers vested in me by section 124 (1) of the Municipal Corporations Law, and of every other power thereunto enabling, I, the Governor, with the advice of the Executive Council, do hereby order that the aforesaid unexpended balance of £1,451.5.4 $\frac{1}{2}p$. be utilized by the Municipal Corporation as a contribution to the Limassol Poor Relief Committee towards the cost of a scheme for establishing an Old Age Hostel in the town of Limassol, and that the principal Order and the amending Order be read together with, and subject to, the provisions of this Order.
