3. The Board of the aforesaid improvement area is willing to treat for the acquisition of the said immovable property.

In exercise of the powers vested in them by section 29 of the Water (Domestic Purposes) Village Supplies Law, the Water Commission of Kato Arkhimandrita village, in the District of
