In exercise of the powers vested in me by the Supplies and Services (Transitional Powers) Act, 1945, as extended to the Colony by the Supplies and Services (Transitional Powers) (Colonies, etc.) Order in Council, 1946, I, the Governor, do hereby order as follows:-

I. These Regulations may be cited as the Defence (Exportation of Goods) Gazettes: (Amendment) Regulations, 1953, and shall be read as one with the Defence (Exportation of Goods) Regulations, 1943 to 1950 (hereinafter referred to as "the principal Regulations"), and the principal Regulations and these regulations may together be cited as the Defence (Exportation of Goods) Regulations, 1943 to 1953.

Suppl. No. 3: 30.12.1943

- 2. Regulation 2 of the principal Regulations shall be varied to read and to have effect as follows:-
 - "2.—(1) Subject to the provisions of regulation 3 of these regulations the export from the Colony of all goods is prohibited save under the authority of a licence granted by the Colonial Secretary (which term shall include any officer duly authorized to act on his behalf) and subject to such terms and conditions (including the price at which such goods shall be sold abroad) as may be specified in such licence.
 - (2) A licence granted under the provisions of paragraph (1) of this regulation may be revoked by the Colonial Secretary at any time before the exportation of the goods to which it relates.
 - (3) Any person aggrieved by the refusal of the Colonial Secretary to grant a licence or by any term or condition specified in any licence or by the revocation of any licence may, within seven days from the notification of the decision of the Colonial Secretary, appeal to the Governor in Council whose decision thereon shall be final and conclusive."
